# Staff Recommendation

1. Recommend approval of renaming park to reflect contributions of John S. DeLorme to the improvement and beautification of Brinkman Park.

2. Recommend renaming to "Brinkman-DeLorme Park."

a. The applicant requested the park be renamed J. DeLorme-Brinkman Park. It is important to set a precedent for the renaming of parks under circumstances that reflect a combination of historical and new names. These standards include the historical name listed first followed by the new proposed name. Additionally, it is recommended that in instances of combining historical and new names into hyphenated names, only last names are used.

The petition request has been unanimously approved by the Sites and Monuments Commission and Park and Tree Commission.

# Public Property Naming Application and Guideline

This application allows for the public to propose a name or to rename public property provided all the requirements outlined in Article E. Section 4:1100-1108 are met.

#### Criteria

All public property names should meet one of the following criteria:

- To honor and commemorate noteworthy persons associated with the City of Savannah,
   Chatham County, State of Georgia, or the United States of America;
- · To commemorate local history, places, events or culture;
- · To strengthen neighborhood identity; or
- To recognize native wildlife or natural features.

### Restrictions

- Persons that resided in the City of Savannah for less than 5 years, other than prominent national figures;
- Names assigned to existing public property within the City or unincorporated Chatham County where duplication of the name is likely to lead to confusion; and
- Except as set forth in Section 4-1106, commercial names where usage of such name would amount to advertising.

## Considerations

Naming requests shall take into account:

- · The number of residents and businesses directly affected;
- Community diversity:
- · The historical significance of preexisting name or location;
- The appropriateness and compatibility of the request in relation to the existing area;
- · The impact on emergency service delivery; and
- Continuity and stability.

# **Natural Person Naming Request**

Requests should consider following;

- Absent extraordinary or extenuating circumstances, the proposed honoree for permanent naming shall be deceased;
- Whether the proposed namesake made a sustained contribution over an appreciable time period, exerted efforts of benefit or significance to local, state or national affairs and/or demonstrated leadership in governmental, cultural or historical affairs, humanitarian efforts, or community development;
- Contributions that beneficially changed the nature and characteristics of the community;
   and
- Achievement by a native Savannahian of national or international acclaim in a specific field of endeavor that has reflected positively on Savannah.



# ARTICLE E. – NAMING AND RENAMING OF PUBLIC PROPERTY, FACILITIES AND STREETS.

Section 4-1100. - General policy.

As a general policy, the Mayor and Aldermen find that public property should be named after its principal function, location, or historical reference; however, significant community events, organizations or well-known persons with important contributions to the community, state or nation may deserve public recognition, which may occur by way of naming or renaming public rights-of-way or facilities.

Section 4-1101- Naming criteria and requirements.

- (a) Naming or renaming of a public right-of-way or facility shall occur only when the proposed naming or renaming satisfied at least one of the following criteria:
  - (1) It honors and commemorates a noteworthy person associated with the City of Savannah, Chatham County, the State of Georgia or the United States of America;
  - It commemorates local history, places, events or culture;
  - (3) It will strengthen neighborhood identity; or
  - (4) It recognizes native wildlife or natural geographical features.
- (b) The following shall not be considered for purposes of naming or renaming:
  - (1) Persons that resided in the City of Savannah for less than 5 years, other than prominent national figures;
  - (2) Names assigned to existing public property within the City or unincorporated Chatham County where duplication of the name is likely to lead to confusion; and
  - (3) Except as set forth in Section 4-1106 of this Article, commercial names where usage of such name would amount to advertising.
- (c) Naming requests shall consider:
  - The number of residents and businesses directly affected;
  - (2) Community diversity;
  - (3) The historical significance of preexisting name or location;
  - (4) The appropriateness and compatibility of the request in relation to the existing area;
  - (5) The impact on emergency service delivery; and
  - (6) Continuity and stability.
- (d) Requests to name a public right-of-way or facility in honor of a natural person should also consider the following:
  - Absent extraordinary or extenuating circumstances, the proposed honoree shall be deceased;
  - (2) Whether the proposed namesake made a sustained contribution over an appreciable time period, exerted efforts of benefit or significance to local, state or national affairs and/or demonstrated leadership in governmental.

- cultural or historical affairs, humanitarian efforts, or community development;
- (3) Contributions that beneficially changed the nature and characteristics of the community; and
- (4) Achievement by a native Savannahian of national or international acclaim in a specific field of endeavor that has reflected positively on Savannah.

Section 4-1102. - Naming new facilities or public property.

- (a) All requests to name newly acquired, created or previously unnamed public property shall be made in writing and directed to the attention of the City Manager. Such requests shall include:
  - (1) The precise location and description of the subject property;
  - (2) A thorough discussion regarding the history of the property or surrounding area, as may be applicable;
  - (3) The name, address and contact information of the requestor; and
  - (4) An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the property is located.
- (b) Upon receipt of a property naming request submitted pursuant to this section, the City Manager shall submit the request to the Historic Sites and Monuments Commission. The Commission shall consider the requirements of this Article and submit a recommendation to the City Manager for presentation to the Mayor and Aldermen no later than 120 days after receipt of the request. Recommendations are subject to approval by City Council.

Section 4-1103 – Renaming of public property, facilities or streets.

- (a) All requests to rename public property shall be made in writing and directed to the attention of the City Manager. Such requests shall include:
  - (1) In the instance of a street or roadway:
    - (A) A supporting petition signed by not less than 75 percent of all property owners abutting the public right-of-way;
    - (B) The present official name of the street;
    - (C) The proposed new name;
    - (D) The specific location of the street or roadway:
    - (E) The name, address and telephone number of the person requesting the name change;
    - (F) A statement of reasons supporting the renaming request;
    - A thorough discussion regarding the history of the right-of-way, including all prior names associated therewith; and
    - (H) An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the right-of-way is located.
  - (2) In the instance of a park, playground, trail, recreational area or space:

- (A) A supporting petition signed by not less than 51 percent of all property owners abutting the subject property;
- (B) The present official name of the property;
- (C) The proposed new name;
- (D) The specific location of the property;
- (E) The name, address and telephone number of the person requesting the name change;
- (F) A statement of reasons supporting the renaming request;
- (G) A thorough discussion regarding the history of the property, including all prior names associated therewith; and
- (H) An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the property is located.
- (3) In the instance of a building, structure or facility:
  - (A) The present official name of the building, structure or facility;
  - (B) The proposed new name;
  - (C) The specific location of the property;
  - (D) The name, address and telephone number of the person requesting the name change:
  - (E) A statement of reasons supporting the renaming request;
  - (F) A thorough discussion regarding the history of the building, structure or facility, including all prior names associated therewith; and
  - (G) An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the building, structure or facility is located.
- (4) In the instance of all other public property:
  - (A) The present official name of the property;
  - (B) The proposed new name:
  - (C) The specific location of the property:
  - (D) The name, address and telephone number of the person requesting the name change;
  - (E) A statement of reasons supporting the renaming request;
  - (F) A thorough discussion regarding the history of the property, including all prior names associated therewith; and
  - (G) An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the property is located.

## Section 4-1104 - Honorary Street Naming Designations.

(a) Honorary street name designations are intended to recognize individuals who have made significant contributions to the City. Where deemed consistent with the objectives of this section, the designation will be a temporary assignment of the honorarium and shall be in addition to the official name of an existing right-ofway.

- (b) Requests to affix an honorary designation to a public right-of-way shall be made in writing and directed to the attention of the City Manager. Submissions shall include:
  - (1) Identification of the particular section or block of an existing City street for which the honorary designation is sought.
  - (2) A supporting petition signed by not less than 51 percent of all property owners abutting the subject right-of-way;
  - (3) The present official name of the right-of-way;
  - (4) The proposed honorary designation;
  - (5) The name, address and telephone number of the person requesting the name change;
  - (6) A statement of reasons supporting the honorary naming request, including a discussion of the historical significance, contributions, heroic service or personal sacrifice by the honoree to the City, state or nation;
  - (7) A discussion regarding the history of the property, including all prior names associated therewith; and
  - (8) An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the property is located.
- (c) Honorary designations may be bestowed under the following non-exclusive circumstances:
  - (1) Where the proposed namesake made a sustained contribution over an appreciable time period, exerted efforts of benefit or significance to local, state or national affairs and/or demonstrated leadership in governmental, cultural or historical affairs, humanitarian efforts, or community development;
  - (2) Where the proposed namesake made contributions that beneficially changed the nature and characteristics of the community;
  - (3) Where the proposed namesake is a native Savannahian whom achieved national or international acclaim in a specific field of endeavor that has reflected positively on Savannah; or
  - (4) Where the proposed namesake resided in the City for at least 5 years.
- (d) Individual family tributes, commercially concerned and corporate-related recognitions shall not be eligible for honorary designation.
- (e) Roadways under the control of the Federal Highway Administration, Georgia Department of Transportation or Chatham County are not subject to honorary naming.
- (f) Honorary designations shall be limited to two City Council-approved designations per calendar. Requests will be reviewed and evaluated in the order in which they are received.
- (g) Upon receipt of a request submitted pursuant to this section, the City Manager shall submit the request to the Historic Sites and Monuments Commission. The Commission shall consider the requirements of this section and submit a recommendation to the City Manager for presentation to the Mayor and Aldermen no later than 120 days after receipt of the request. Recommendations are subject to approval by City Council.

- (h) Requests approved by the Mayor and Aldermen shall be effective for five years from the date of such approval. The City may remove the sign at the end of the five-year period. If requested, the sign may be given to the applicant, honoree, or a family member of the honoree.
- (i) Renewal requests may be submitted; provided, however that they are transmitted no less than 60 days before the termination of the effective period. Renewal requests will not be given priority over pending honorary designation requests, if any.
- (j) Honorary signs may be mounted on the same post as the existing street sign or mounted free standing on a separate post. The City will maintain the sign after installation. Installation of the honorary sign(s) shall be within a reasonable time but no later than 45 days from the date of approval. The City shall replace signs stolen or damaged during the five-year approval period.
- (k) Along with any application submitted, the applicant shall include payment of a non-refundable fee to defray the costs associated with the review, design, fabrication, installation and maintenance of the sign. The fee shall be charged as set forth in the City's annual Revenue Ordinance. All fees will be deposited in the City's General Fund upon receipt. Fees and costs shall not be waived unless the honorary designation is initiated by City Council.

Section 4-1105. - Naming Dedication Ceremony

An applicant may request a dedication ceremony at the time application is made to the City Manager. The City Manager, or his designee, shall be responsible for scheduling such ceremony.

Section 4-1106. - Donations and Gifts

A donation or gift of land, goods, funding, equipment or other items may constitute a basis upon which to name or rename public property. The donation or gift shall be documented and recorded by the Clerk of Council.

Section 4-1107. - Notification of street name changes; publishing and posting of notices.

When the name of a street permanently has been changed pursuant to this Article, the public works administrator shall notify utility companies and interested state and local agencies of the street name change. Notifications may encompass more than one renaming event and may be provided by publication in a newspaper of general circulation.

Section 4-1108. - Discontinuance.

The City retains the right to reject, discontinue or abandon any naming that occurred pursuant to this Article when deemed in the best interests of the health, safety and welfare of its residents and visitors.

- John Delorme was a life long resident of Parkside. His parents moved to Parkside in 1962. He lived there almost continuously until his death in 2017.
- John, a resident of 1314 E. 49<sup>th</sup> Street, served as President of Parkside Neighborhood Association for close to a decade, assuming leadership of the association in the late 1990s.
- As President, John played an important role in the designation of the neighborhood on the National Register of Historic Places in 1999.
- In 2001, John made a formal request to the City of Savannah to create a sign in Brinkman Park as an entry point to the neighborhood to enhance neighborhood pride and visually recognize the history of Daffin Park and the Parkside neighborhood.
- John coordinated with neighborhood residents to design, produce and install a sign and landscaping beautification, which were installed in 2002.
- John made a request to the City under the City's Property Enhancement Program, agreeing to assume maintenance of the park, which at that time had only minimal maintenance from the city. John renewed this request several times as President.
- For six years, John arranged for mowing and maintenance of the park out of dues from Parkside Neighborhood Association, and in between, he would singlehandedly clean the park and remove debris and trash, saving the City significant maintenance costs.
- As President, John organized monthly meetings, speakers and annual block parties and events to foster community and neighborhood pride.
- A history major, John documented every house in Parkside in photographs, interviewed older residents, and maintained a scrapbook of newspaper articles related to the neighborhood.
- John regularly advocated on behalf of his neighborhood to the City on issues from zoning to crime.
- John was ahead of his time, promoting and recognizing the history of Parkside more than a decade before the City's celebration of Daffin Park and Parkside's centennial in 2013.
- In late 2004, after suffering seizures, John was diagnosed as having a chordoma, a rare, skull-based tumor.
- John resigned his duties as President in 2007, only after his brain tumor had advanced, prompting numerous surgeries and radiation treatment.
- For years after his tenure as president, in between recovery from brain tumor surgeries, John continued to regularly maintain and clean the park.
- John continued to participate in Parkside Neighborhood Association meetings until two months before his death from complications caused by his brain tumor in January 2017.

Buildings, structures, objects and districts can be added to the approximately 70,000 listings of the National Register of Historic Places, an inventory begun in the 1960s in response to the estruction of historically significant sites in the name of urban renewal. According to Edson Boall, a historian with the Vational Parks Service. properties can be listed under our criteria:

# What the historic designation means for homeowners

A listing in the register recognizes a property's importance and ensures the property will be taken into account in the planning of federally funded or licensed projects. Additionally, rehabilitated homes



# Three major elements determine how fast an area

will succeed in its mixed-use zones. And the property

Experts say the area needs three ingredients to morph into a flourishing area - it has knocked two off the list. But the final ingredient remains as to whether the neighborhoods of Daffin Park tip toward a scene of thriving neighborhoods and businesses.

#### Instructions

If there were a recipe for balancing commercial and residential areas, Samuel Simowitz, the commercial sales manager with Konter Realty Co., would be the chef du jour.

According to Simowitz, there are three major elements that determine the speediness of whether an area will flourish in its mixed-use zones

The recipe for success calls for three ingredients.

One: If an area is blighted, filled with vacancies or is "begging for a different use, the process is likely to be swift, including if there is a move by a developer to begin such an upgrade."

Two: There must be a high best use factor for the area - that the area is capable or is used to the fullest of its resources.

Three: The acceptance and encouragement of such growth by the surrounding residents

The results: A chain reaction between the deveopment and real estate values of neighboring area

With rising businesses there are rising real estat rates. But what makes Daffin Park ready to chang is its unique ability to mix old neighborhood chan with new businesses.

Technically, the area would be stereotyped und. "suburbla," but its unique architecture and the hi tory of its houses has earned it a spot on the lot fthe National Historic Register of Landmarks.

And unlike most places in Savannah, its conn allows businesses to border alongside the neighbe hoods - recalling a more close-kuit time whou redents walked to work or the store

#### Comments/Recommendations:

Requirements include a supporting petition signed by not less than 51 percent of all
property <u>owners</u>. The applicant provided a petition signed by two property owners of

1108 East 49<sup>th</sup> Street and two tenants of 1110 East 49<sup>th</sup> Street. Upon review of the Chatham County Tax Assessor's Property Record Cards, 1108-1110 East 49<sup>th</sup> Street is one property owned by the two petition signers of 1108 East 49<sup>th</sup> Street (PIN 2-0085-08-014, Lots 247-248 Pierpont Ward). This is the property immediately east of the park in question. Since Brinkman Park is the only park in the Parkside Neighborhood, designated in 1924, and has been supported by the Parkside Neighborhood Association since 2001 (see attachment "Brinkman Park"), it is recommended additional comment be solicited from the abutting property owners within the bounds of Parkside (this would include those to the north and south of the park) and the members of the Parkside Neighborhood Association.

- 2. The application includes the present name of the park, Brinkman Park, and includes a letter from Kristen Aspaas and George Shaw that states "We appreciate the generous gift the original donor made to the city." There is no additional information provided in the application regarding the history of the property or the original donor. The Library & Archives recently completed a brief review of the history of Brinkman Park (see attachment "Brinkman Park"). The park land was donated to the City by the Parkside Land Company in 1922. In 1924, City Council passed a resolution setting aside the land as a public park under the management of the Park and Tree Commission. No record of the park's official naming has been located in City records. However, during this period it was typical for City wards and parks to be named for City leaders, particularly mayors and aldermen. It is likely that Brinkman Park is named for Henry Christian Brinkman (1871-1934), who served as aldermen for several terms between 1925 and 1934. Brinkman died of a heart attack while serving as alderman in 1934. It is unknown when the park began to be referred to as Brinkman Park.
- The packet received by the Library & Archives lacked an endorsement by the Mayor or an alderman for review.

#### Criteria

All public property names should meet one of the following criteria:

- To honor and commemorate noteworthy persons associated with the City of Savannah, Chatham County, State of Georgia, or the United States of America;
- ☐ To commemorate local history, places, events or culture;
- ⊗ To strengthen neighborhood identity; or
- ☐ To recognize native wildlife or natural features.

#### Comments/Recommendations:

 The application and supporting documents testify that John DeLorme was instrumental in improving and beautifying Brinkman Park, as both President of the Parkside Neighborhood Association and as a private citizen. The Library & Archives' research in City records documents that John DeLorme, as Parkside Neighborhood Association President, led an effort to improve and beautify Brinkman Park, starting in November 2000 when he petitioned City Council on behalf of the Association for permission to adopt the park (in order to pick up trash, mow grass, sweep the sidewalk, and perform minor landscaping) and install a sign identifying the Parkside Neighborhood, utilizing the City's new Property Enhancement Program. His efforts were successful in gaining attention for the park and its improvement, and installing a sign drawing attention to Parkside as a distinct and historic neighborhood.

#### Restrictions

Persons that resided in the City of Savannah for less than 5 years, other than prominent
national figures;
Names assigned to existing public property within the City or unincorporated Chatham
County where duplication of the name is likely to lead to confusion; and

#### Considerations

Naming requests shall take into account:

- ⊗ The number of residents and businesses directly affected;
- ☐ Community diversity;
- ⊗ The historical significance of preexisting name or location;
- ☐ The appropriateness and compatibility of the request in relation to the existing area;
- ☐ The impact on emergency service delivery; and
- ⊗ Continuity and stability.

#### Comments/Recommendations:

- Brinkman Park is a neighborhood park. It is the only park within the bounds of the Parkside Neighborhood. It has been supported by the Parkside Neighborhood Association over the years through maintenance and beautification efforts. As such, renaming of the park would directly affect all residents of the neighborhood, not just those immediately adjacent to it.
- The historical significance of the preexisting name, Brinkman, has not been fully
  documented at this time, though it is believed to be named for Henry Christian
  Brinkman. It is not recommended to remove names which previous generations have
  chosen to honor without a full understanding of specifically who they are named for and
  why.

To provide continuity to the use of the name Brinkman Park, it is recommended to maintain the historical portion of the name first and include the new addition second.

- Absent extraordinary or extenuating circumstances, the proposed honoree for permanent naming shall be deceased;

- Contributions that beneficially changed the nature and characteristics of the community; and

#### Comments/Recommendations:

- John Stephen DeLorme was born January 2, 1962 and died on January 12, 2017. He was a native of Savannah, and a graduate of Benedictine Military School and Armstrong State University. - Research conducted by the Library & Archives on Brinkman Park and documentation submitted by the applicant demonstrate the sustained efforts of John DeLorme to maintain and improve Brinkman Park for the benefit of the Parkside community for almost twenty years.

#### Research Library & Municipal Archives Recommendations

- Recommend approval of renaming park to reflect contributions of John DeLorme to the improvement and beautification of Brinkman Park.
- 2. Recommend renaming to "Brinkman-DeLorme Park."
  - a. The applicant requested the park be renamed J. DeLorme-Brinkman Park. Since this is the first application for the renaming of a park under this ordinance, it is important to set a precedent for the renaming of parks under circumstances that reflect a combination of historical and new names. It is recommended this be consistently handled moving forward with a naming convention standard by presenting the historical name first and then the new addition. Additionally, it is recommended that in instances of combining historical and new names into hyphenated names, only last names be used.

 Recommend notification of Historic Site and Monument Commission meeting during which the application will be considered be forwarded to the Parkside Neighborhood Association for dissemination to the neighborhood residents.



Brinkman Park is located on the northeast corner of East 49th Street and Waters Avenue, encompassing three lots (Lots 244, 245, 246, Pierpont Ward) in the Parkside Place Historic District. The passive park measures approximately 9,450 square feet or 0.22 acres, features seven (7) trees and a few boxwoods and azaleas, and is currently maintained by the Park and Tree Department.

Brinkman Park is listed in an inventory of the City's scenic parks and squares as a neighborhood park with a capacity for 50.1

Parkside Place Historic District is bounded by Victory Drive, Waters Avenue, Bee Road and East 51st Street Lane, and was placed on the National Register of Historic Places in 1999. Parkside Land Company laid out Parkside Place and began selling lots in 1913. The residential subdivision is comprised of mostly single family dwellings. The development company set covenants/restrictions on the lots as they were sold starting in 1916, which remained in effect until 1936. Lots are typically 100 feet deep and range from 60-120 feet wide. Brinkman Park is the only park within the bounds of Parkside Place, as the neighborhood makes use of Daffin Park, immediately adjacent to the north.<sup>2</sup>


Parkside Place was annexed into the City of Savannah's corporate limits in August 1914. In exchange for the City of Savannah extending a water main along Waters Avenue and grading the streets within Parkside Place, the Parkside Land Company deeded the streets to the City of Savannah. The entire subdivision was designated within the City's ward system as Pierpont Ward, named and

defined by City Council on February 3, 1915. At the same time, the City's streets were officially extended through Pierpont Ward. The 1916 Sanborn Insurance Map of Savannah reflects early development in Parkside Place, with residences starting to appear on lots. However, Lots 244, 245 and 246, Pierpont Ward are depicted as vacant on the 1916 map (see below).

On October 4, 1922, the Parkside Land Company deeded Lots 244, 245, and 246, Pierpont Ward to the Mayor and Aldermen of the City of Savannah. The deed included Parkside's original covenants/restrictions and was signed by company President, James T. Wells, and attested to by Secretary, Paul E. Seabrook (Seabrook would soon serve as Savannah Mayor, from January 22, 1923-

January 26, 1925). Following receipt of the deed transferring ownership, City Council acknowledged and accepted the transfer of property as a gift from the Parkside Land Company.<sup>6</sup>

In a resolution passed on April 30, 1924, City Council set aside the Pierpont Ward lots given to the City by the Parkside Land Company in 1922 as a public park under the management of the Park and Tree Commission:

By the Committee of the Whole. Resolved by the Mayor and Aldermen of the City of Savannah, in Council assembled, that that certain tract of land conveyed to the Mayor and Aldermen of the City of Savannah by deed, dated October 4th, 1922 from the Parkside Land Company and recorded in the records of Chatham County, Georgia, Book 17 N's, Folio 175, and described in said deed as being those three certain lots, tracts or parcels of land situate, lying and being in Pierpont Ward, in the City of Savannah, Chatham County, Georgia, and shown and designated upon a certain plat and survey made by W. O'D. Rockwell, C. E., for the Parkside Land Company, recorded in Map Book 1 in the records of Chatham County, Georgia, as lots numbers 244, 245 and 246, said lots lying contiguous and having a combined frontage of ninety (90) feet by a rectangular depth of one hundred and five (105) feet and as a whole bounded on the North by a lane; on the East by lot No. 247, Pierpont Ward; on the South by 49th street and on the West by Waters Avenue, be and the same is hereby set aside as a public park and as such, the Park and Tree Commission for the City of Savannah shall have the exclusive management of all matters and things relative to the care, preservation, improvement, adornment, good order and regulation thereof. Adopted and approved.<sup>7</sup> [underline added for emphasis]

No record of the park's official naming has been located in the City Council's records or the Park and Tree Commission's records. However, during this period it was typical for City wards and parks to be named for City leaders, particularly mayors and aldermen. It is likely that Brinkman Park is named for H. C. Brinkman. Brinkman served as alderman for five terms, dying in office during his fifth term from a heart attack following a car accident:

Brinkman, H(enry) C(bristian) (born 1871, died 1934)

- alderman January 26, 1925 January 24, 1927
- alderman January 24, 1927 January 21, 1929
- alderman January 21, 1929 January 26, 1931 (vice- chairman of council)
- alderman December 28, 1932 (replaced Garrard Haines who died December 18, 1932) January 23, 1933
- alderman January 23, 1933 August 19, 1934 (died)<sup>8</sup>

Upon his death, City Council passed a resolution on September 5, 1934 memorializing Brinkman's public service:



That in the death of Alderman Henry Christian Brinkman, on the 19th day of August 1934, the City of Savannah has sustained a great loss, and this Body has been deprived of the services of one its most conscientious and painstaking members... No man ever served the City of Savannah in an official position who was more devoted to his duties than Alderman Brinkman. Unselfishly and unsparingly he gave a large portion of his time daily to the City's business. By reason of his thorough knowledge of the financial affairs of the City and of his grasp of business details and his infinite patience and great firmness, he was largely instrumental in steering the City of Savannah through the financial crisis which prevailed for the past several years. Not only has the Board of Aldermen been deprived of his valuable counsel and painstaking labors, but the community itself has lost one of its most public-spirited citizens. Savannah could ill afford to lose such a splendid citizen and high-minded public official whose devotion to his public duty and his love for the City of Savannah were always placed by him above his provate [sic] interests...?

Brinkman served as Chairman of the Finance Committee and was described by Mayor Thomas Gamble as the "right arm" of the City government. He was a native of Neuenlande, Germany, immigrating to Savannah around 1885, and was an active member of the German County Club and the German Friendly Society.<sup>10</sup>




Pierpont Ward, 1939.11







Maps prepared by the Georgia Southern Area Planning and Development Commission in the late 1960s or early 1970s identify the park as needing improvements, but it is unclear if any were ever made (see above).

In November 2000, the Parkside Neighborhood Association, through Association President John DeLorme, petitioned City Council for permission to adopt the City lot on the corner of East 49th Street and Waters Avenue (in the petition it was not referred to as Brinkman Park), as well as for permission "to erect a sign calling attention to our historic neighborhood." The petition stated the Association would pick up trash, mow grass, sweep the sidewalk, plant flowers and small bushes, and perform other minor landscaping. It further called out that "this lot needs all the help it can get." In a memo to City Council dated March 28, 2001, City Manager Michael Brown mentioned that with approval of this petition the Parkside Neighborhood Association would "become the first group to participate in the Property Enhancement Program whereby a group or citizen is allowed the use of a City owned lot as a passive park or garden in exchange for maintaining the lot. This program was

designed to reduce City costs to clear and mow the yard and to reduce blight by having the neighborhood become responsible for the maintenance of the land."14

It seems that between the lots' designation in 1924 as a public park and this approval in 2001, the City had ignored the park to such an extent that it was regarded as simply undeveloped and uncared for lots rather than an actual park.

The Association's petition to encroach on the property to erect the sign was approved by City Council on April 5, 2001, with the comments "that the encroachment grants no rights to the property and, if ever required by the City, [the sign] must be removed at the Association's expense." The sign was permitted through the City's Department of Inspections (Permit #00-43685) and manufactured by Sign Mart. It is a single-sided, oval wood sign featuring the text "Parkside Place Historic District, Established 1913." <sup>15</sup>
