Re: Notice of Hearing to Show Cause – February 1, 2018

Dear Mr. Webb:

According to records maintained by the City's Revenue Department, you are the principal and alcoholic beverage license holder for Moving Forward Management d/b/a Own Time Sports and Comedy Grill, a/k/a Over Time Sports Bar and Grill.

Shortly before 10:00 p.m. on January 1, 2018, E-911 fielded three calls reporting shots fired and injured persons within your establishment. Savannah-Chatham Metropolitan Police Department officers responded and were confronted by a locked door. You emerged and reported that fireworks had been deployed within the building. To the contrary, video surveillance footage revealed a physical altercation began around 9:30 p.m., which escalated to include the use of pool balls as weapons and, ultimately, the discharge of firearms. The surveillance also shows you and your staff searching for and collecting evidence associated with the incident prior to the arrival of law enforcement. Additional investigation indicated a lack of adequate security on January 1st leading to multiple breaches. In short, and among other issues, the security plan you submitted to the City was not followed.

In view of the foregoing, the City considers your establishment to be in violation of the Alcoholic Beverage Ordinance of 2017 and intends to take appropriate action to the extent authorized by the City Code. To that end, City Council has directed this office to provide you with notice of a public hearing, which will occur on February 1, 2018 at 2:00 p.m. in City Hall, 2nd Floor, in the Council chamber. At that time, you will be required to show cause why your alcoholic beverage license should not be suspended or revoked pursuant to Section 6-1207(b) of the City Code.

You may be represented by counsel at the public hearing, and you and your attorney will have an opportunity to cross-examine all witnesses and to examine any evidence presented. You will also have the right to present witnesses, testimony and other evidence.
