Recommend approval to award construction contract for the Hudson Hill Community Center building to Paul S. Akins Company, Inc. in the amount of \$2,774,826.25.

The contract will be used to construct the new Hudson Hill Community Center at 2227 Hudson Street in the Hudson Hill neighborhood, more specifically at the Rebecca N Gray Memorial Park. This project provides a new community center of 4,800 square feet, replacing the previous 3,800 square foot community c enter that was demolished. The new facility consists of classrooms, offices, a large assembly space with commercial kitchen. Construction is anticipated to commence in October of 2021 and be complete within 10 months.

Due to all bids being above the budgeted amount for this project, the office of Capital Projects Management worked with the low bidder to value engineer the project and bring it in line with the approved budget.

Paul S. Akins Company, Inc. has committed to meet the 20% DBE goal including a 10% LDBE goal set for this project.
