AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM AN R-6 (SINGLE-FAMILY RESIDENTIAL – 6 UNITS PER NET ACRE) ZONING CLASSIFICATION TO AN R-M-6 (RESIDENTIAL-MULTIFAMILY – 6 UNITS PER NET ACRE) ZONING CLASSIFICATION; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

Thence proceeding in a SW direction along the approximate centerline of Savannah Christian School Drive for approximately 513.666 ft. to a point, [X: 996238.696811 Y: 735097.737857],

Thence proceeding in a SE direction [S 74-54-4 E] along a line of for approximately 157.897 ft. to a point, [X: 996391.142996 Y: 735056.607951], said point being, THE POINT OF BEGINNING

Thence proceeding in a SE direction [S 74-54-4 E] along a line [Northern boundary line of property PIN 2-0138 -01-043A] for approximately 300 ft. to a point,

Thence proceeding in a SW direction [S 15-5-56 W] along a line [Eastern boundary line of property PIN 2-0138 -01-043A] for approximately 251.048 ft. to a point,

Thence proceeding in a NW direction [N 75-5-4 W] along a line [Southern boundary line of property PIN 2-0138 -01-043A] for approximately 297.477 ft. to a point,

Thence proceeding in a NE direction [N 14-31-30 E] along a line [Western boundary line of property PIN 2-0138 -01-043A] for approximately 252.012 ft. to a point, [X: 996391.142996 Y: 735056.607951], said point being, THE POINT OF BEGINNING
