AN ORDINANCE To Be Entitled

AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM A R-A-CO (RESIDENTIAL-AGRICULTURAL, ANNEXED) ZONING CLASSIFICATION TO AN A-1 (AGRICULTURE) ZONING CLASSIFICATION; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: The following described property be rezoned from its present R-A-CO zoning classification to an A-1 zoning classification:

Thence proceeding in a SE direction along the approximate centerline of Fort Argyle Road (Hwy 204) for approximately 669.268 ft. to a point [X: 926296.982431 Y: 732604.157376], said point being, THE POINT OF BEGINNING

SECTION 3: That the requirements of Section 8-3182(f)(2) of said Code and the law in such
cases made and provided has been satisfied. An opportunity for a public hearing was afforded
anyone having an interest or property right which may have been affected by this zoning amendment,
said notice being published in the Savannah Morning News, on theday of,

made a part hereof.
<u>SECTION 4</u> : All ordinances or parts of ordinances in conflict herewith are hereby repealed.
