## SECOND AMENDMENT TO TOWER ATTACHMENT LEASE AGREEMENT

This Second Amendment (the "Second Amendment") to that certain Tower Attachment Lease Agreement dated July 10, 1996 by and between Savannah MSA Cellular and City of Savannah, as amended by that certain First Amendment to Tower Attachment Lease Agreement dated May 14, 2009 (collectively, the "Lease") is made and entered into as of the latter signature date hereof, by and between American Towers LLC, a Delaware limited liability company, as successor in interest to Savannah MSA Cellular (the "Lessor") and City of Savannah, Georgia (the "Lessee") (collectively, the "Parties").

## RECITALS

WHEREAS, Lessor owns a certain communications tower and leases a certain parcel of land located at 500 LUCAS DRIVE, Savannah, GA 31406-8505 more commonly known to Lessor as the MONTGOMERY (SA) GA tower site (the "Premises"); and

WHEREAS, Lessor and Lessee entered into the Lease for the use of a certain portion of the Premises; and

WHEREAS, Lessee desires to modify its equipment at the Premises ("Modified Equipment"), which also includes unlicensed equipment ("Unlicensed Equipment"); and

WHEREAS, the Parties agree that as consideration for Lessee's Modified and Unlicensed Equipment, the current License Fee payable under the Lease shall be increased as set forth herein.

NOW THEREFORE, in consideration of the foregoing promises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

- 1) Lessor and Lessee agree and acknowledge that Lessee shall modify its equipment for a final installed configuration pursuant to Exhibit B-2.
- 2) Lessor and Lessee agree and acknowledge that Exhibit B-1 to the Lease is hereby deleted in its entirety as of the date this Second Amendment is fully executed and shall be replaced with Exhibit B-2 attached hereto and incorporated by this reference. In the event of inconsistency or discrepancy between Exhibit B-2 and Lessee's equipment information set forth in the Lease, Exhibit B-2 shall control.
- 3) Effective upon January 1, 2017, as to the Unlicensed Equipment, the lease payment shall be increased by Fifty and 00/100 Dollars (\$50.00) per month appropriately prorated for any fractional month at the beginning or end of the period.

4) Effective upon the earlier to occur of: i) commencement of installation of the Modified Equipment; or ii) July 15, 2017 ("Commencement Date"), the lease payment shall be increased by Seven Hundred Fifty and 00/100 Dollars (\$750.00) per month, for a total lease payment of One Thousand Six Hundred and 00/100 Dollars (\$1,600.00) per month, appropriately prorated any fractional month at the beginning or end of the period.

- 5) Notwithstanding anything to the contrary in the Lease, the offer to Lessee expressed in this Second Amendment shall automatically become null and void with no further obligation by either party hereto if a structural analysis of the Premises completed after the execution of this Second Amendment by Lessor but before the Commencement Date of the installation of Lessee's Modified Equipment indicates that the Premises is not suitable for Lessee's Modified Equipment unless Lessor and Lessee mutually agree that structural modifications or repairs shall be made to the Premises on mutually agreeable terms.
- 6) Capitalized terms contained herein, unless otherwise defined, are intended to have the same meaning and effect as that set forth in the Lease.
- 7) All other terms and provisions of the Lease remain in full force and effect.
