## AN ORDINANCE To Be Entitled

AN ORDINANCE TO RECLASSIFY CERTAIN PROPERTY FROM ITS PRESENT RESIDENTIAL-GENERAL COMPREHENSIVE PLAN FUTURE LAND USE MAP CLASSIFICATION TO A COMMERCIAL-SUBURBAN FUTURE LAND USE MAP CLASSIFICATION; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES:

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: The following described property be reclassified from its present Residential-General Future Land Use Map classification to a Commercial-Suburban Future Land Use Map classification:

Commencing from a point [X: 975723.532909 Y: 729466.581712], located at the approximate intersection of the centerlines of the right-of-way for Montgomery Cross Road & the approximate centerline of Savannah Square Drive, said point being, THE POINT OF BEGINNING

Thence proceeding in a SW direction along the approximate centerline of Savannah Square Drive for approximately 476.339 ft. to a point [X: 975556.075012 Y: 729020.647719],

Thence proceeding in a NW direction [N 73-49-52 W] along a line for approximately 253.55 ft. to a point,

Thence proceeding in a NE direction [N 18-4-42 E] along a line for approximately 376.57 ft. to a point,

Thence proceeding in a SE direction [S 75-32-13 E] along a line for approximately 19.45 ft. to a point,

Thence proceeding in a NE direction [N 18-9-18 E] along a line for approximately 90.629 ft. to a point, [X: 975476.489904 Y: 729530.490406], said point being located at the approximate centerline of the right-of-way for Montgomery Cross Road,

Thence proceeding in a SE direction [S 75-29-45 E] along the approximate centerline of the right-of-way for Montgomery Cross Road for approximately 255.176 ft. to a point, [X: 975723.532909 Y: 729466.581712], said point being, THE POINT OF BEGINNING

amendment notice procedure, and the law in such cases made and provided has been satisfied. An
