AN ORDINANCE TO BE ENTITLED

AN ORDINANCE TO AMEND THE ALCOHOLIC BEVERAGE ORDINANCE, ARTICLE H OF PART 6 OF THE CODE OF THE CITY OF SAVANNAH (2003) SECTIONS 6-1204, 6-1205 AND ADDITION OF CHAPTER 9 TO RECOGNIZE STATE LAW CHANGES; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE EFFECTIVE DATES AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia in regular meeting of Council assembled, and pursuant to lawful authority thereof;

<u>SECTION 1</u>: That Article H of Part 6 of the Code of the City of Savannah, Georgia (2003) Section 6-1204, Definitions, be amended by adding thereto:

- (s) "Manufacturer" means a Class B license holder and refers to any maker, producer, or bottler of an alcoholic beverage as defined by Title 3 of the Official Code of Georgia Annotated, as amended, which also includes:
 - (1) In the case of distilled spirits, any person engaging in distilling, rectifying, or blending any distilled spirits; provided, however, that a vintner that blends wine with distilled spirits to produce a fortified wine shall not be considered a manufacturer of distilled spirits;
 - (2) In the case of malt beverages, any brewer; and
 - (3) In the case of wine, any vintner.

<u>SECTION 2</u>: That Article H of Part 6 of the Code of the City of Savannah, Georgia (2003) Section 6-1204, Definitions, subsection (a)(2), "Ancillary retail package store", be deleted in its entirety and a new Section 6-1204(a)(2) be inserted in lieu thereof as follows:

- (2) Derives from such retail sale of malt beverages or wine in unbroken packages less than 25 percent of its total annual gross sales.
- <u>SECTION 3</u>: That Article H of Part 6 of the Code of the City of Savannah, Georgia (2003) Section 6-1204, Definitions, subsection (n), "Sample", be deleted in its entirety and a new Section 6-1204(n) be inserted in lieu thereof as follows:
 - (n) "Sample" means the *gratis* provision by a manufacturer, retail package store or ancillary retail package store of a one ounce or less portion of wine or malt beverage to a person over the age of 21.

<u>SECTION 4</u>: That Article H of Part 6 of the Code of the City of Savannah, Georgia (2003) Section 6-1205(c), License Required, be deleted in its entirety and a new Section 6-1205(c) be inserted in lieu thereof as follows:

(c) The following licenses, or any combination thereof, may be issued pursuant to this Article; provided, however that such combination is not prohibited by Title 3 of the Official Code of Georgia Annotated, as amended, the regulations issued pursuant thereto, as amended, or any other applicable law concerning the sale or dispensation of alcoholic beverages.

<u>SECTION 5:</u> That Article H of Part 6 of the Code of the City of Savannah, Georgia (2003) Section 6-1211(a), Hours of sale and operation for retail dealers, be amended by deleting the third sentence and inserting the following in lieu thereof:

All Class C licensees shall close no later than 2:55 a.m. on Sunday and shall not open before 7:00 a.m. on Monday.

<u>SECTION 6</u>: That Article H of Part 6 of the Code of the City of Savannah, Georgia (2003) be amended to add a new Division 8, Special Provisions Related to Distillers and Brewers, as follows:

Division 8. – Special Provisions Related to Distillers and Brewers.

Section 6-1222. Distillers and Brewers. Notwithstanding anything to the contrary set forth in this Article, distillers and brewers shall be permitted to provide Samples and shall have the same privileges as a Retail Dealer and a Retail Package Store, provided that such activities shall be subject to:

- (a) The limitations contained in Title 3 of the Official Code of Georgia, as amended; and
- (b) The license conditions and restrictions applicable to sales or dispensation conducted pursuant to Class C or Class D licenses set forth in the Article, respectively.

<u>SECTION 7</u>: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

<u>SECTION 8</u>: This ordinance shall become effective when signed by the Mayor.
