AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM A R-M-25 (MULTIFAMILY RESIDENTIAL 25 UNITS PER ACRE), FOUR-FAMILY RESIDENTIAL (R-4), COMMUNITY BUSINESS (B-C), AND LIGHT INDUSTRIAL (I-L) ZONING DISTRICTS TO THE R-M-25 (MULTIFAMILY RESIDENTIAL 25 UNITS PER ACRE) ZONING DISTRICT; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: The following described property, 0 Sterling Street (portions), be rezoned from its present R-M-25, R-4, B-C, I-L Zoning Districts to the R-M-25 Zoning District:

Tract A (Northern Property to include Wheaton, Pounder, Joe, Rockefeller Streets)

Commencing from a point [X: 992661.330912 & Y: 753420.886177], located at the approximate intersection of the centerlines of the right-of-way for Wheaton Street & Sterling Street,
