July 9, 2020 – 11:00 a.m.

City Manager Monahan gave a brief outline of the financial and compliance audit process and then introduced Finance Director David Maxwell.

Mr. Maxwell introduced Mr. Miller Edwards and Mr. Trey Scott of Mauldin and Jenkins, who presented the details of the City's financial and compliance audit via a slide presentation.

Following the presentation, there was a question and answer session by the Mayor and Aldermen with Finance Director David Maxwell and representatives of Mauldin and Jenkins.

2. Millage Rate Discussion

City Manager Monahan gave detailed information on the current millage rate and the impact of the rollback rate. Mr. Monahan introduced Chief Finance Officer David Maxwell, Revenue Department Director Ashley Simpson, and Chief Budget Officer Melissa Carter.

The Mayor and Aldermen asked questions of Mr. Maxwell, Ms. Carter, and Ms. Simpson relating to the millage rate and the impact of a rollback millage rate. Ms. Carter asked for a consensus from the Council to proceed

with the advertisement of the millage rate.

Mayor Johnson asked Council for a consensus:

- Alderwoman Wilder-Bryan keep current millage rate, 12.856
- Alderman Palumbo keep current millage rate, 12.856
- Alderwoman Gibson-Carter adopt rollback rate, 12.739
- Mayor Pro-Tem Dr. Shabazz adopt rollback rate, 12.739
- Alderman Purtee 2020 Budgeted rate, 12.856
- Alderwoman Miller Blakely adopt rollback rate, 12.739
- Alderwoman Lanier adopt rollback rate, 12.739

As a result of his polling, Mayor Johnson directed staff to advertise the millage rate at the 2020 budgeted rate of 12.856 which is a tax increase, and if the Mayor and Aldermen decide to lower the millage rate to the 12.739 rollback rate, they will make that decision later.
