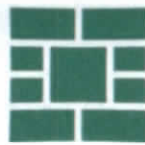

In reference to the application of **Pareshkumar Patel, T/A Pump N Go**, requesting an alcoholic beverage license at **2016 Skidaway Road**, I have determined that the **Proposed Use, Fuel Station with Convenience Store that sells beer and wine by the package/Ancillary Retail Package Store**, within the current **B-C Zoning District** (formerly B-C):

- Is Not Permitted.
- Requires a Special Use Permit from the Mayor and Aldermen.
- Is Permitted as a Nonconforming Use.
- Is Permitted with the Following Condition(s):
- Is Permitted by Right.**

Additionally, I have determined that the **Proposed Use:**


