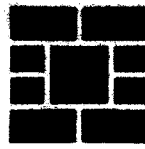

Re: Zoning Review of Alcoholic Beverage License Request 21-005748-ABL

In reference to the application of **Diane Montford Boyette, T/A Captain's Lounge**, requesting an alcoholic beverage license at **8414 Waters Ave**, I have determined that the **Proposed Use, Bar; tavern with Retail consumption dealer (on premise consumption of alcohol)** within the current **B-C Zoning District**:

- Is Permitted by Right:** The principal use classification *Bar; tavern* is permitted by right in the zoning district.
- Is Not Permitted.
- Obtained a Special Use Permit from The Mayor and Aldermen.
- Is Permitted as a Nonconforming Use.
- Is Permitted as a Limited Use with Standard(s):** The accessory use classification *Retail consumption dealer (on premise consumption of alcohol)* is permitted as a limited use with standards per Article 5 Sec. 5.4 Principal Use Table. Per Article 8 Sec. 8.7.24(b)(i), the use is permitted by right, because the parcel is not within the boundaries of an Alcohol Density Overlay District. Alcohol sales are limited to on-premises consumption only.

Additionally, I have determined that the **Proposed Use**:

- Is an Existing use/occupancy, but new ownership, management or request.**
- Is a new use/occupancy.


Additionally, I have determined that the **Location**:

- Zoning Ordinance violations that need to be corrected prior to the issuance of the Alcoholic Beverage License.
- Has a recent Business Location Approval for the *Bar; tavern* principal use classification per File No. 21-004486-BA approved October 12, 2021.**






