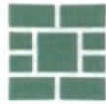

In reference to the application of **Richard C. Kessler, T/A JW Marriott Savannah – Plant Riverside District – ADD FAC Pavilion 3 District Riverside Biergarten and Sushi**, requesting an alcoholic beverage license at **300-500 West River Street**, I have determined that the **Proposed Use, Restaurant with Retail consumption dealer (on premise consumption of alcohol)**, within the current **D-W (Downtown Waterfront) Zoning District**:

I have determined that the **Proposed Use**:

- Is Permitted by Right
- Is Not Permitted
- Requires a Special Use Permit from The Mayor and Aldermen
- Is Permitted as a Limited Use with Standards:** The proposed principal use *Retail consumption dealer (on premise consumption of alcohol)* in association with a restaurant is a use permitted, as a limited accessory use per Article 8 Sec. 8.7.24 of the zoning ordinance.
- Is Permitted as a Nonconforming Use.
