

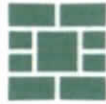

Randolph Street Development (660 East Broughton St) is located in the Hitch Village/ Fred Wessels Homes neighborhood where there's no active association.

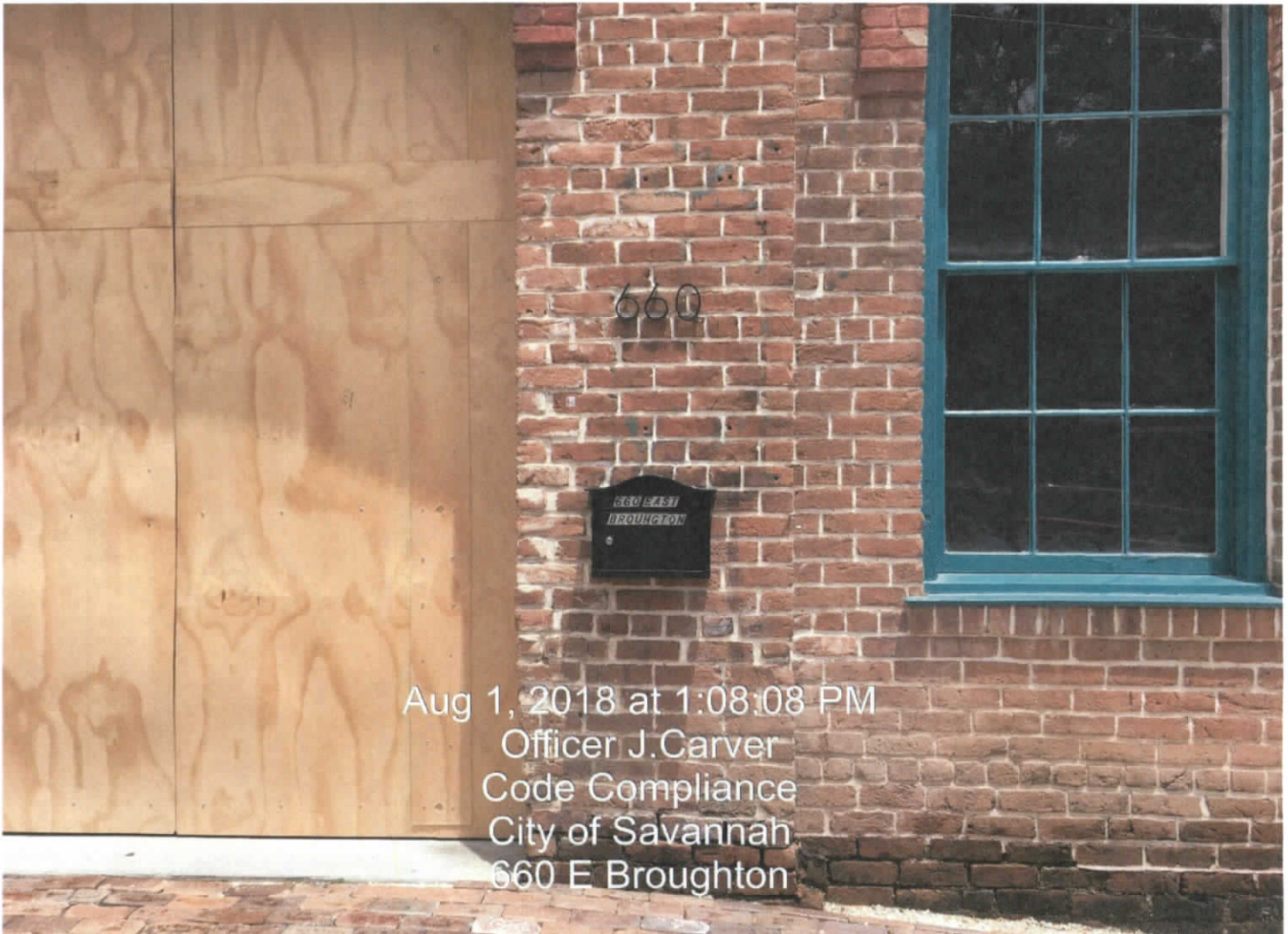


