b. The proposed use will not be contrary to the purposes stated for this chapter.

The proposed use would establish a restaurant with alcohol sales on Abercorn Street, which is appropriate.

c. The proposed use will not affect adversely the health and safety of residents and workers in the city.

d. The proposed use will not be detrimental to the use or development of adjacent properties or the general neighborhood.
