

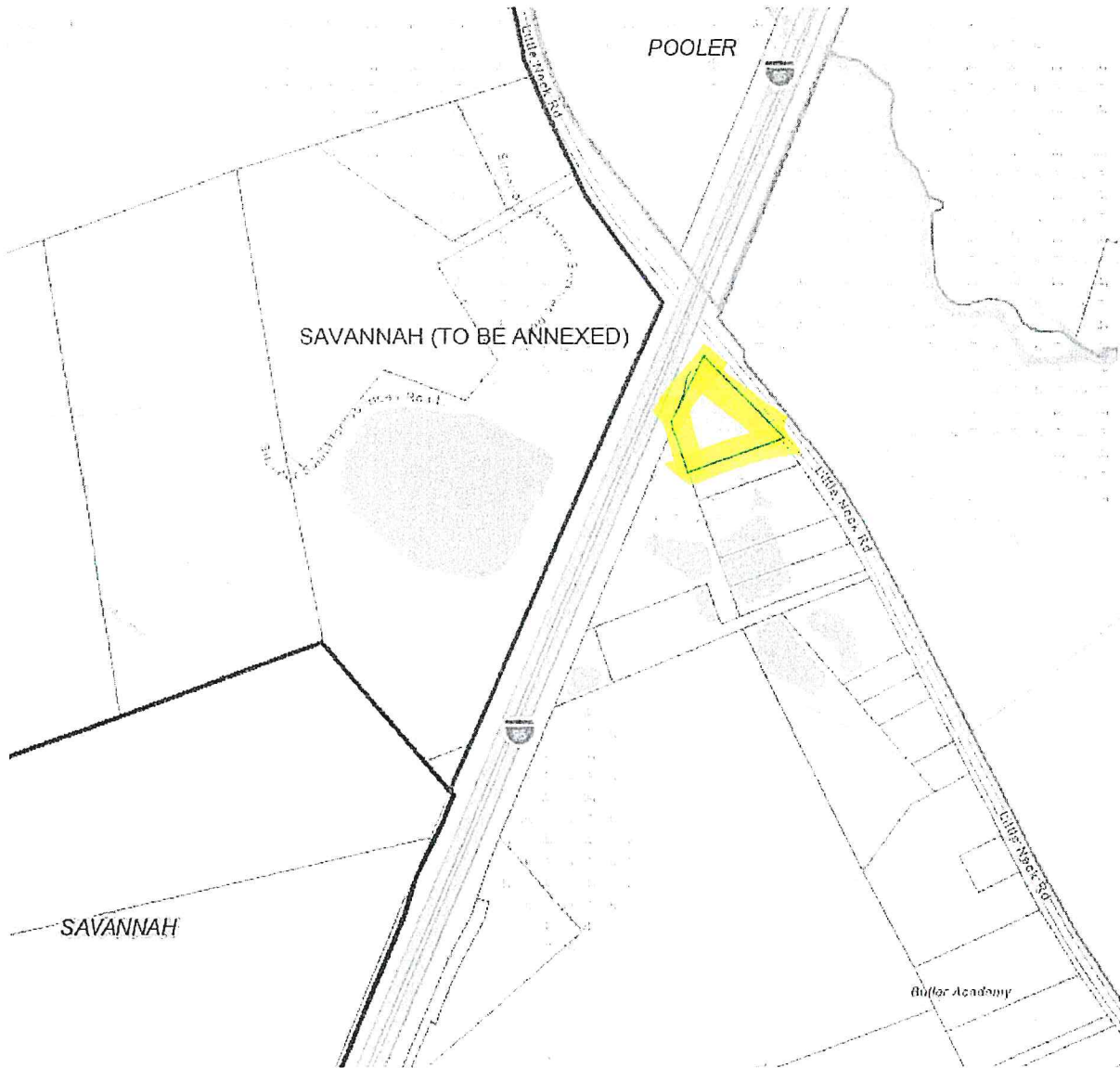

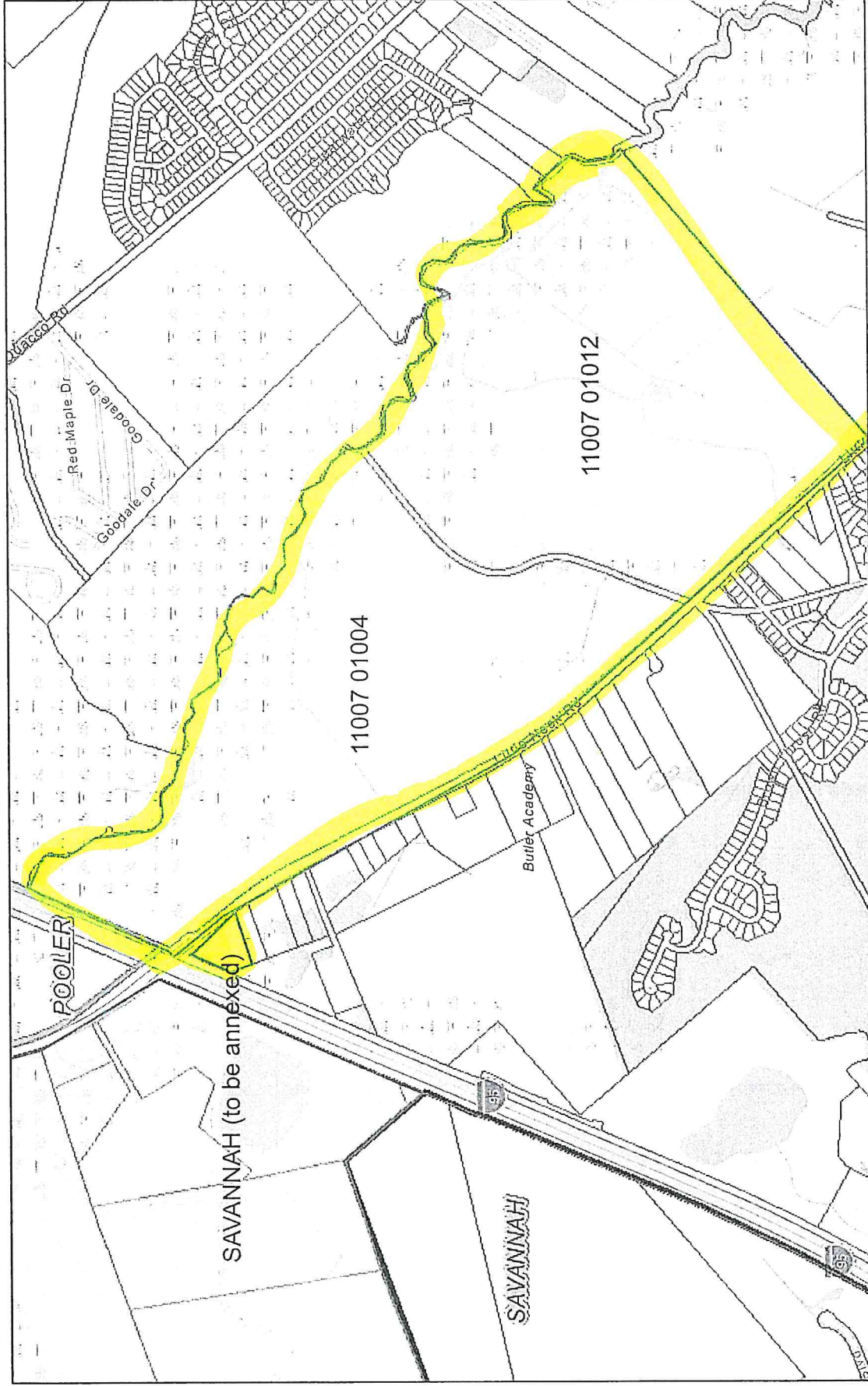

TAX PARCEL ID NUMBERS: 1-1007-01-004 and 1-1007-01-012

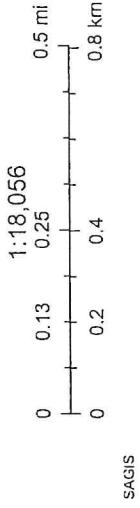
Being a portion of Hopeton Plantation.
