4.0 The purpose of these specifications is to describe requirements for various sizes of repair clamps and sleeves to be utilized by the Water Distribution Department.

To submit pricing electronically for this event, enter pricing for each line item shown under the lines tab on the event summary. Manually submitted bids must be submitted on the bid proposal forms contained in these specifications in order to be considered. Bids may be submitted manually to the address listed in the bid documents in sufficient time to ensure receipt by the Purchasing Department on or before 1:30 P.M. on the date specified in the web page listing for this event.

A pre-bid conference has been scheduled to be conducted at the Purchasing Office, 301 West Oglethorpe Avenue, Savannah, Georgia, 31401. This meeting will allow contractors to discuss the specifications and resolve any questions and/or misunderstandings that may arise with City staff. You are invited to attend. - 4.7 Band to be of high grade stainless steel; non-corrosive high tensile strength; type 304.
- 4.8 Lugs to be of high strength cast iron or ductile iron.
- 4.9 Bolt and Nut heat treated, steel bolts and nuts electroplated with chromate finish or Cor Ten AWWA C111-10.
- 4.10 Gasket high quality rubber or equal waffle pattern.
- 4.11 All clamps size 2"-12" will be single band type and anything larger will be double band type.
- 4.12 All bolts will be hex-head type which will prevent slipping of bolt during installation of clamp.
- 4.13 Quantities shown on bid proposal are estimates only and are based on previous years' usage. The City reserves the right to purchase more or less than the estimated quantities

4.14 Basis of Award

This contract will be awarded to the vendor offering the lowest net price to the City, and meeting or exceeding all specifications herein. The City of Savannah reserves the right to split this award if deemed in the City's best interest. This may include appointing primary, secondary, and/or tertiary vendors if deemed advantageous.

4.15 This is an annual contract. Prices must remain firm for the duration of the contract. This agreement may be renewed for up to two (2) additional twelve (12) month periods, if all contracting parties so agree and services provided by the vendor have been satisfactory. The first term of this contract shall begin upon award and shall end on December 31, 2019. All remaining renewal options, if exercised, shall begin on January 1 and end on December 31 of each subsequent year.

5.0 **General Specifications**:

5.1 The bid response shall include all documents required in the bidder's checklists

All referenced documents must be completed and returned in their entirety to constitute a complete bid.

- 5.2 To be awarded a bid, bidders must be registered as a supplier on the City of Savannah's website at <u>www.savannahga.gov</u>.
- 5.3 **Bidders must provide the manufacturer and part number of each item bid in the space** provided on the bid form.

- 5.5 The successful vendor must have the following items on every invoice to the City:
 - A) The exact description of the purchased item as described in this contract,

- 5.6 <u>Very Important</u>: Vendor is responsible for acknowledging any addenda issued in connection with this bid solicitation. All addenda issued for this event <u>must</u> be acknowledged in order for a bid to be considered.
- 5.7 **Non-Communication Period**: Those intending to respond to this event, their employees, agents and attorneys, shall not make contact with City Council members or with City staff outside of the Purchasing Department during the bidding process and evaluation phase.

Instruction for Completing Systematic Alien Verification for Entitlement (SAVE) Form

O.C.G.A. § 50-36-1, requires Georgia's cities to comply with the federal **Systematic Alien Verification for Entitlements (SAVE) Program**.
