JUSTIFICATION: This change order includes the project Summary Change Order (project contract final increase or decrease of line item quantities). This project involved the replacement of 174 LF of open ditch and road crossing culvert with a 3x6 ft precast culvert. The precast culvert utilized a water tight gasket (ASTM C1677) that had not been used by the City of Savannah previously. Procurement of the new gasketed culvert required a 127 day extension to the contract. The contract price deductions were mostly due to the project being completed in one phase and not requiring undercutting and replacement.
