AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM A B-N (NEIGHBORHOOD BUSINESS) ZONING CLASSIFICATION TO A TC-1 (TRADITIONAL COMMERCIAL) ZONING CLASSIFICATION; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.
