AN ORDINANCE To Be Entitled

AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM LIGHT INDUSTRIAL (I-L) AND MULTIFAMILY RESIDENTIAL, 25 UNITS PER NET ACRE (R-M-25) TO A MULTIFAMILY RESIDENTIAL, 40 UNITS PER NET ACRE (R-M-40) ZONING CLASSIFICATION; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: The following described property be rezoned from its present I-L and R-M-25 zoning classifications to an R-M-40 zoning classification:

Beginning at a point located at the approximate intersection of the centerlines of Wheaton Street & Live Oak Street, said point being, THE POINT OF BEGINNING

Thence proceeding in a NW direction along the approximate centerline of Wheaton Street for approximately 148.00 ft. to a point,

Thence proceeding in a NE direction [N 51-31-38 E] along a line for approximately 253.56 ft. to a point,

Thence proceeding in a SE direction [S 39-56-22 E] along a line for approximately 46.73 ft. to a point,

Thence proceeding in a SE direction [S 43-42-33 E] along a line for approximately 89.00 ft. to a point,

Thence proceeding in a SE direction [S 58-8-33 E] along a line for approximately 73.60 ft. to a point,

Thence proceeding in a NE direction [N 44-46-28 E] along a line for approximately 429.00 ft. to a point,

Thence proceeding in a NE direction [N 17-54-27 E] along a line for approximately 150.55 ft. to a point,

Thence proceeding in a SE direction [S 59-45-39 E] along a line for approximately 162.656 ft. to a point,

Thence proceeding in a SW direction [S 18-54-27 W] along a line for approximately 116.53 ft. to a point,

Thence proceeding in a SE direction [S 21-19-23 E] along a line for approximately 62.32 ft. to a point,

Thence proceeding in a SW direction [S 17-59-29 W] along a line for approximately 540.63 ft. to a point,

Thence proceeding in a NW direction [N 63-18-31 W] along a line for approximately 197.36 ft. to a point,

Thence proceeding in a SW direction [S 18-21-28 W] along a line for approximately 137.55 ft. to a point, said point being located on the approximate centerline of Wheaton Street,

Thence proceeding in a NW direction along the approximate centerline of Wheaton Street for approximately 409.86 ft. to a point, said point being, THE POINT OF BEGINNING
