Updates from Atlanta- ON THE RADAR



HB 523 Short Term Vacation Rentals

Would not allow registration of short term rentals and require that they be treated the same as long-term rentals or properties that are not rented

HB 832 Parks Require Heat Prevent Equipment

Requires parks used by youth athletic organizations to be equipped with certain vessels for heat related injuries

HB 674 State-Wide Alcohol Application and Renewal Portal

Department of Revenue aims to develop a state-wide centralized application portal for alcohol licenses and renewals.

HB 852 Taxation of Public Lands Taxation of public lands held outside of jurisdiction

<u>SB 159 Scooter Regulations Remain Under Local Control</u> Protects local control of regulation regarding scooters

<u>SB 39 Destroying Confiscated Firearms</u> (Sen. Lester Jackson) allow cities to destroy confiscated firearms

HR 935 Georgia Commission on Freight and Logistics

Extension of the Commission until the end of this year to work toward solutions for infrastructure and logistics challenges




Governor's Anti-Gang Effort

- Governor's budget calls for \$1.6 million to add seven GBI agents and analysts to the gang task force
- Governor's budget outlines \$420,000 towards a gang database for local and state law enforcement
- Extends reach of law enforcement agencies across county lines
- Adds death penalty as option for gang-related murder convictions
- Allow security officers to make arrests up to 880 yards outside of school campuses.
- Allow prosecutors to seize gang property








HB 238 (Rep. Matthew Wilson)	Only dealers may legally sell firearms at gun shows
SB 34 (Rep. Emanuel Jones)	Would restrict access to guns from people with mental illness issues
SB 33 (Sen. Emanuel Jones)	Outlaw carrying guns into government buildings
HB 122 (Rep. Robert Trammel)	Repeal campus carry
HB 55 (Rep. Roger Bruce)	Restrict producing guns with 3D printers.
SB 39 (Sen. Lester Jackson)	Allow cities to destroy confiscated firearms.
HB 20 (Rep Debra Bazemore)	Restrict guns from people convicted of domestic violence crimes
HB 58 (Rep. Rhonda Burnough)	Restrict guns from people convicted of domestic violence crimes
SB 50 (Sen. Sally Harrell)	Repeal campus carry
HB 165 (Rep. Robert Trammel)	Reinstates the requirement for fingerprint background check on renewals
HB 289 (Rep. Mary Margaret Oliver)	Bans bumpstocks and classifies them as machine guns
HB 361 (Rep. Pedro Marin)	Require training to obtain Georgia Weapons License
SB 78 (Sen. Emanuel Jones)	Require training to obtain Georgia Weapons License
SB 105 (Sen. Jennifer Jordan)	Violate due process for confiscating firearms
SB 365 (Sen. Zahra Karinshak)	Imposes Brady Law across the state of GA
SB 366 (Sen. Zahra Karinshak)	Require background checks for any firearm sold in GA
