### AN ORDINANCE TO BE ENTITLED

#### AN ORDINANCE TO AMEND THE CHARTER OF THE CITY OF SAVANNAH TO REAPPORTION DISTRICTS FROM WHICH MEMBERS OF THE MAYOR AND ALDERMEN OF THE CITY OF SAVANNAH ARE ELECTED; TO REPEAL ALL LAWS IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Mayor and Aldermen of the City of Savannah, Georgia, in regular meeting of Council assembled, and pursuant to Ga. Laws 1981, page 497, O.C.G.A. § 36-35-3, and after proper notice and advertisement in accordance with O.C.G.A. § 36-35-3, that the Charter of the City of Savannah be amended to reapportion the election districts from which member of the municipal governing body are elected, as follows:

<u>SECTION 1</u>: The six (6) Aldermanic Districts of the City of Savannah shall be composed of portions of territory of Chatham County lying within the corporate limits as follows:

### District 1:

## **DISTRICT 1** [Portion A]
