AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM THE TN-2 (TRADITIONAL NEIGHBORHOOD) ZONING CLASSIFICATION TO A P-D (PLANNED DEVELOPMENT) ZONING CLASSIFICATION; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: The following described property be rezoned from its present TN-2 zoning classification to a P-D zoning classification:

<u>SECTION 1A:</u> Property description:

Commencing from a point [X: 988668.284108 & Y: 748526.589863], located at the approximate intersection of the centerlines of East 39th Street & East Broad Street,

Thence proceeding in a NW direction along the approximate centerline of East 39th Street for an estimated distance of 142.6 ft. to a point, said point being, THE POINT OF BEGINNING

Thence proceeding in a SW direction [S 17-26-34 W] along a line for an estimated distance of 117.2 ft. to a point,

Thence proceeding in a NW direction [N 72-22-40 W] along a line for an estimated distance of 30.5 ft. to a point,

Thence proceeding in a NE direction [N 14-26-34 E] along a line for an estimated distance of 117.4 ft. to a point, said point being located along the approximate centerline of East 39th Street,
