AN ORDINANCE TO REZONE CERTAIN PROPERTY FROM AN I-L (LIGHT INDUSTRIAL) ZONING CLASSIFICATION TO AN IL-T (LIGHT INDUSTRIAL-TRANSITION) ZONING CLASSIFICATION WITH CONDITIONS; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: The following described property be rezoned from its present I-L zoning classification to the IL-T zoning classification:
