NOTES

Recommend approval to award an annual contract for Armed Security Services for Various City Locations to Sunstates Security, LLC in the amount of \$1,523,836.81. Sunstates has been the main security contractor for City facilities since 2016. Throughout that time, they have proven their commitment to the City of Savannah by not only keeping us safe, but often remaining flexible and covering very short notice details without an issue. Additionally, they have provided staffing at requested City of Savannah temperature checkpoint throughout the pandemic.

The City of Savannah facilities covered under this contract:

- 1. City Hall
- 2. Gamble Building
- 3. Savannah Morning News
- 4. Ellis Square
- 5. Coastal Georgia Center
- 6. I & D Water Plant

- 10. Any special detail requested by the Risk Management Department

The method used for this procurement was the request for proposal, which evaluated other criteria in addition to cost. Proposals were evaluated on the basis of qualifications and experience, wages, benefits, and training, references, local vendor participation, and fees.

Nine proposals were originally received for this request. The proposals were then reviewed and shortlisted to the top three, who then presented to the selection committee. The selection committee was comprised of staff from Risk Management, SPD, Public Works and Parking Services. After the presentations were completed the fee proposals were opened and the pricing was incorporated into the scoring.

The bid was advertised, opened, and reviewed. The contract term expires on December 14, 2022. This contract also includes four (4) available annual renewal options. Delivery: As needed. Terms: Net 30 days. The bidders were:
