Baughman, T/A World Market-Cost Plus, Inc.**, requesting an alcoholic beverage license at **7805 Abercorn Street, Suite 14C**, I have determined that the **Proposed Use, Retail, General that sells beer and wine by the package as an Ancillary Retail Package Store**, within the current **B-C Zoning District** (formerly B-C):
