

FIRST AMENDMENT TO SUBRECIPIENT AGREEMENT  
(CFDA NO. – 14.231)

This First Amendment to Subrecipient Agreement (CFDA No. 14.231), dated as of December 31, 2018, is made by and between The Mayor and Aldermen of the City of Savannah and Family Promise of Greater Savannah.

WITNESSETH:

WHEREAS, the parties entered into a subrecipient agreement as of January 1, 2018 pursuant to a Resolution dated November 9, 2017 whereby the City agreed to provide a grant of \$123,421 in Emergency Solutions Grant (“ESG”) funds to Family Promise of Greater Savannah (“Subrecipient”); and

WHEREAS, Subrecipient, a non-profit community organization concerned with providing services to prevent homeless, agreed to use the ESG funds to assist eligible persons with rent and utility payments to prevent them from becoming homeless, a cause supported by the City of Savannah; and

WHEREAS, Subrecipient agreed to perform certain tasks and undertake responsibilities more specifically enumerated in, *inter alia*, Articles I and II of the Parties January 1, 2018 Agreement; and

WHEREAS, the parties’ Article IV of the Agreement provides that the Agreement shall be effective through December 31, 2018 unless adjusted by written agreement between the parties; and

WHEREAS, Subrecipient has not exhausted all of the ESG funds and has requested an extension through July 31, 2019 so as to enable it to provide additional persons with homelessness prevention assistance; and

WHEREAS, the City has no objection to extending the Agreement to allow for the expenditure of remaining funds and delivery of preventative services to eligible persons; and

WHEREAS, the contemplated contract extension does not conflict with the terms and conditions of the ESG;

NOW, THEREFORE, in consideration of these promises, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Incorporation of Recitals. The foregoing recitals are true and correct and incorporated as if fully set forth herein.

2. Extension of Term of Agreement. Pursuant to Article IV B., the parties hereby agree to extend the time of performance set for the in Article IV A. from December 31, 2018 through July 31, 2019.

3. Miscellaneous. The parties agree that, except as modified by this Amendment, the Agreement remains in full force and effect in accordance with its terms. In the event of a conflict between this Amendment and the Agreement, the terms of this Amendment shall control. This Amendment may be executed in multiple counterparts which, taken as a whole, shall constitute one instrument. This Amendment may be executed by facsimile signature.
