The large water meters will be used by the Water Distribution Department to install new water meters in need of replacement and also to replace existing meters to Badger Orion/Beacon radio read water meters for the transition to the new advanced metering infrastructure (AMI) system.</p> <p>The lowest responsive, responsible bidders were selected for each line item. The apparent low bidder was not selected for the meter register line item because the proposed register did not meet the specifications in section 4.5.5. The apparent low bidder for the line items for the ten inch domestic meters and the ULFM meters were not selected because they did not meet the specifications in section 4.2.2.</p> <p>The contract term shall be January 3, 2019 through December 31, 2019.
