Claims/Litigation Process

- Claim is made either informally or by formal petition/ ante litem notice → processed by Risk Management & evaluated by City Attorney's Office
- Investigated and settled by Risk Management and/or referred to City Attorney's Office
- Ante litem filed with Clerk of Council → answered by City Attorney's Office
- If lawsuit is filed, it is handled by City Attorney's Office

- Won: 30
- Settled: 13*
- Active lawsuits as of today: 55
