SPECIFICATIONS AND SPECIAL CONDITIONS

4.0 The purpose of these specifications is to describe requirements for replacement stage curtains and track for the Johnny Mercer Theatre located within the Savannah Civic Center.

To submit pricing electronically for this event, enter pricing for each line item shown under the lines tab on the event summary. To enter pricing manually, complete the attached bid proposal form. Manually submitted bids must be submitted on the bid proposal forms contained in these specifications in order to be considered.

A pre-bid conference has been scheduled to be conducted at the Purchasing Office, 1375 Chatham Parkway, second floor, Savannah, Georgia 31405. This meeting will allow contractors to discuss the specifications and resolve any questions and/or misunderstandings that may arise with City staff. You are invited to attend.

4.1 Specifications

Bidder shall supply the following equipment. All deliverables shall be FOB Savannah, Georgia.

4.1.1 Main curtain

Two (2) panels, 32 feet H by 39 feet W each, 32oz IFR Synthetic Velour, trade name: Royale, Black, Unlined, 75% fullness, twelve inch (12") onstage hem, two inch (2") offstage hem, six inch (6") bottom hem with ribbon weight, top webbing/hooks/grommets twelve inch (12") on center

4.1.2 Main Valance

One (1) panel, 16 feet H by 70 feet W, 32 oz IFR synthetic velour, trade name: Royale, Black, Unlined, 75% fullness, two inch (2") side hems, three inch (3") bottom hem with ribbon weight, top webbing/grommets/ties twelve inch (12") on center

4.1.3 Legs

One (1) panel, 36 feet H by 71 feet W, 22oz IFR synthetic velour, trade name: Encore, Black, Unlined, 50% fullness, twelve inch (12") onstage hem, two inch (2") offstage hem, six inch (6") bottom hem with ribbon weight, top webbing/grommets/ties twelve inch (12") on center

4.1.4 Borders.

(4) panels, 16'Hx71'W, 22oz IFR Synthetic Velour, trade name: Encore, Black, Unlined, 0% fullness, 2"side hems, 3" bottom hem w/ribbon weight, top webbing/grommets/ties 12" on center.

4.1.5 Mid Traveler.

(2) Panels 32'Hx37"W, 22oz IFR Synthetic Velour, trade name: Encore, Black, Unlined, 50% fullness, 12" onstage hem, 2" offstage hem, 6" bottom hem w/ribbon weight, top webbing/grommets/install ties and supply hooks 12" on center.

4.1.6 Full Stage Black.

(1) Panel, 36'Hx71'W, 22oz IFR Synthetic Velour, trade name: Encore, Black, Unlined, 50% fullness, 12" onstage hem, 2" offstage hem, 6" bottom hem w/ribbon weight, top webbing/grommets/ties 12" on center.

4.1.7 Scrim

One (1) Panel, 36 feet H by 70 feet W, Seamless Sharktooth Scrim, Black, 0% fullness, two inch (2") side hems, four inch (4") bottom pipe pocket with support sleeve, top webbing/grommets/ties twelve inch (12") on center

4.1.8 Shell Masking

One (1) Panel, 12 feet H by 60 feet W, 13oz IFR synthetic velour, trade name: Apollo aka Plateau, Black, Unlined, 0% Fullness, two inch (2") side hems, three inch (3") bottom hem with ribbon weight, top webbing/hidden sewn ties

4.1.9 Main Curtain Track

ADC 280 Curtain Track. One (1) complete set for Main Drape as specified herein. Overall length 76 feet with a two foot (2^{*}) combined overlay at center. Bids shall include all necessary accessories, including all hangers, carriers, stops, pulleys, hand line, and any additional hardware necessary to complete installation to batten as specified by manufacturer and allow for typical operation.

4.1.10 Mid Traveler Track

ADC 280 Curtain Track. (1) complete set for Mid Traveler as specified herein. Overall length 72' with a 2' combined overlay at center. Please quote as "comes with all necessary accessories" to mean all hangers, carriers, stops, pulleys, hand line and any additional hardware necessary to complete installation to batten as specified by manufacturer and allow for typical operation.

Coverage should fully extend for period of repose for the State of Georgia

Instruction for Completing Systematic Alien Verification for Entitlement (SAVE) Form

O.C.G.A. § 50-36-1, requires Georgia's cities to comply with the federal **Systematic Alien Verification for Entitlements (SAVE) Program**. SAVE is a federal program used to verify that applicants for certain "public benefits" are legally present in the United States. Contracts with the City are considered "public benefits."
