The low bidder, O.C. Welch Ford Lincoln, Inc., submitted a bid in the amount of \$362,800.00. J.C. Lewis Ford's original bid was \$368,163.00. Because J.C. Lewis Ford's original bid was within 7% of the low bid, J.C. Lewis Ford was offered the opportunity to match the low bidder's pricing. J.C.
