ANNEXATION PETITION. The City received an annexation petition for approximately 6,561 acres of territory in the area generally south of Interstate 16 and west of Interstate 95. The area consists of 15 contiguous tracts owned by eleven different corporations and individuals which have all joined in the petition: J.C. Lewis, Jr., John Kent Lester, U.C. Realty Corporation, Blue Sky Timber Properties LLC, Lancaster 204 LLC, 204 Partners LLC, G. Bart Redmond and Eric Morgan, William L. Grainger, Little Neck Road Properties Partnership, and International Paper Realty Corporation. The land is contiguous to existing City territory, and therefore can be annexed by ordinance adopted by City Council. As required by State law the County has been informed of receipt of this petition.

The owners are seeking annexation to gain access to the City's municipal services. The City is the only provider of water and sewer service with adequate capacity at reasonable cost, and to gain access to this utility service on in-city terms, the owners desire annexation. Annexation will allow the City to fully participate in the benefits created by the development of this territory, which was made possible by the City utility system. This annexation is supportive of Council's economic development and fiscal efficiency priorities. Mixed residential and commercial

development of the parcels is expected with a total of approximately 13,850 equivalent residential units after build-out.

City Manager Brown explained that this would be the City's recommended formal acceptance and receipt of an annexation petition that is actually from 15 contiguous tracts and 11 different corporations and individuals as noted on the agenda. He stated that Mr. Mike Vaquer was present to speak as the representative for these petitioners. Mr. Vaquer came forward and stated that he was serving as the spokesperson for the 11 different owners of 15 separate parcels. They have petitioned City Council to be annexed into the City of Savannah. These property owners have looked at the growth and development of their properties as long as two years ago. During this period, they did a thorough evaluation of the different options they had on the methods of getting both water and sewer and other services to these properties. They evaluated being outside the City of Savannah and contracting with the City to bring water and sewer to these properties. They also evaluated dealing with other municipalities to bring water and sewer services to these properties with private individuals to bring the same kind of services. At the end, every finger pointed to the best option available to these individuals to have timely service delivery in an efficient and economical manner, was to bring these properties into the City of Savannah to allow them to move forward with orderly growth and development. Mr. Vaquer appeared today to present the petition to Council and ask for their acceptance to move this issue forward.

Alderman Clifton Jones stated that an article in Savannah Morning News talked about a takeover, but this is not a takeover as the request came from these landowners. Mayor Johnson stated that this was correct and he felt very annoyed at the headlines in the newspaper. It appeared as if this annexation was being initiated by the City and it was not. This was initiated by a petition of the landowners to the City Council and he wanted the public to be clear on this. Alderman Clifton Jones moved to accept the petition. This was seconded by Alderman Cook. Mayor Johnson called for the discussion on the motion. Alderman Felser pointed out to the public that the City has the water services and believes that we can do this in a timely, efficient and effective manner. The motion carried to accept the petition for the annexation.
