Recommend approval to award an annual contract for grounds maintenance for City facilities and cemeteries to Russell Landscape, Inc. for up to \$607,624. The Real Estate Services Department will use the grounds maintenance services for City facilities and cemeteries (Laurel Grove North, Laurel Grove South and Greenwich).

Grounds maintenance services for the three cemeteries will begin in December 2020 because the previous contractor abruptly resigned in September. The grounds maintenance services at other City facilities will commence January 1, 2021 which include the following sites:
