<p>Recommend approval to award a construction contract for the Gwinnett Street widening project to Preferred Materials, Inc. in the amount of \$13,662,942.10. The Public Works and Water Resourced Department will use these services to widen the existing two-lane roadway to a four-lane roadway. This project also includes the widening of the Springfield Canal, the construction of a new bridge to raise the existing roadway elevations, and sidewalk and bike lane additions. This project will extend approximately 200 feet west of the Gwinnett Street and Stiles Avenue intersection. Gwinnett Street will be closed for the duration of construction and traffic will be diverted via detour. Due to existing environmental issues, a remediation workplace was provided for monitoring and testing during the construction. The project is estimated to last 24 months.</p> <p>The bid was advertised, opened, and reviewed. Delivery: As needed. Terms: Net 30 days.
