<p>Recommend approval to renew an annual contract for water meters with Badger Meter, Inc. in the estimated amount of \$1,466,100.00. The water meters will be used by the Public Works and Water Resource Department to replace meters that are past their useful life and for the installation of new water services for public and private developments. Most of the meters are stocked in inventory at the Central Warehouse and some are stocked by the Public Works and Water Resource Department. In addition, some meters are also purchased by contractors for private developments. The existing City of Savannah water meters are a combination of both automated meter-radio read (AMR) units and direct read meters. This contract allows for installation of new automated meter-wireless-infrastructure units to replace the AMR and/or direct read meters. The low bidder was selected for all items except one, where the apparent low bidder did not include the cost for cellular endpoint in its cost proposal.</p> <p>Bids were originally received August 29, 2017 and approved in Council on November 21, 2017 in the amount of \$1,466,100.00.
