The services will be used by the Office of Capital Projects Management to install a new gangway platform for the recreational and fire dock at Rousakis Plaza.</p> <p>In November 2016, the platform connecting the recreational dock to Rousakis Plaza collapsed. This project will install a new platform to the bulkhead at the same location. The dock will be connected to the platform by the original gangways. Minor repair work of the gangways is included in this project. In addition, there will be additional work done to the docks. This includes running new water and electrical lines to the shore power stations, replacing pile guides, replacing walers, installing new tie-rods, and making spall repairs. This project will make the dock functional again as there is no current access from the dock to the Riverwalk.</p> <p>The bid was advertised, opened, and reviewed. Delivery: As requested.
