

BUDGET AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE ANNUAL BUDGET FOR THE YEAR 2017 FOR VARIOUS GOVERNMENTAL FUNDS OF THE CITY OF SAVANNAH, GA

WHEREAS, the Mayor and Aldermen duely adopted the 2017 Service Program and Budget on December 22, 2017; and

WHEREAS, the City of Savannah's budget process allows for amendments as conditions change or circumstances are altered; and

WHEREAS, O.C.G.A 36-81-3 requires the adoption of a reolution or ordinance in order to approve a budget amendment

THEREFORE, BE IT ORDAINED by the Mayor and Aldermen of the City of Savannah in Council assembled that the following amendment to the 2017 Service Program and Budget be made:
