### SCRAP TIRE DISPOSAL

#### EVENT NO. 6904

#### SPECIFICATIONS AND SPECIAL CONDITIONS

4.0 The purpose of these specifications is to describe requirements for the transportation and disposal of passenger and oversized scrap tires from the City of Savannah's Fleet Services facility located on Sallie Mood Drive, the Westside facility located at the intersection of Stiles Avenue and Gwinnett Street, the Dean Forest Road Landfill, and the Bacon Park Transfer Station.

To submit pricing electronically for this event, enter pricing for each line item shown under the lines tab on the event summary. To enter pricing manually, complete the attached bid proposal form. Manually submitted bids must be submitted on the bid proposal forms contained in these specifications in order to be considered.

A pre-bid conference has been scheduled to be conducted at the Purchasing Office, 301 West Oglethorpe Avenue, Savannah, Georgia, 31401. This meeting will allow contractors to discuss the specifications and resolve any questions and/or misunderstandings that may arise with City staff. You are invited to attend.

- 4.1 The City desires to contract services for the pick-up and legal disposal of approximately 19,600 passenger and 400 oversize truck tires annually. The City will contact the vendor(s) on an as-needed basis to pick up tires. Vendor(s) shall pick up tires within five days of notification.
- 4.2 A trailer shall be provided by the successful contractor for the Dean Forest Road Landfill (53 foot closed trailer), Bacon Park (53 foot closed trailer), the Fleet Services facility located at 6900 Sallie Mood Drive (28 foot closed trailer and 48 foot open trailer when requested), and City Lot located at 1100 West Gwinnett Street (28 foot closed trailer). The trailer will be weighed at the contractor's location and an electronic ticket will be provided to the City in which the City will pay by the ton for disposal of tires from the Landfill, Bacon Park and Fleet Services Department locations. Number and locations of trailers is subject to change.
- 4.3 The successful bidder will be required to weigh-in empty and full on the scales located at the Dean Forest Landfill, to ensure accuracy of weights.
- 4.4 All fees, transportation charges, etc. shall be included in the unit pricing provided.
- 4.5 Contractor Responsibilities
  - 4.5.1 The City will issue a manifest to the contractor for each pick-up. This manifest will describe the material quantity and composition, and will also state the origin, routing, and destination of the scrap tires from origin to destination. End user, processor, or disposer will be approved by the Environmental Protection Division. Manifest shall include the following information:
    - 1. Name and ID# of the generator.
    - 2. Number of scrap tires.

- 3. Name and permit of the scrap tire carrier.
- 4. Date of transport.
- 5. Destination of scrap tires.
- 4.5.2 The contractor shall be EPD certified and have a certified EPD processor. Bidders must include with the bid submittal a copy of the certificate designating the authorized EPD carrier and processor to be further considered. The contractor must provide the City with the same information with the completed manifest within 30 days of a scrap tire pickup date on which the carrier took possession of scrap tires. Failure to comply with these provisions will be grounds for termination of the contract.
- 4.5.3 The contractor shall provide all personnel, equipment, and other resources for the loading and transporting and the unloading of tires. The City will store the tires in accessible containers furnished by the contractor at no additional charge. The vendor is not responsible for loading tires into container. Equipment to be used for work performed under this contract shall be listed on Attachment A and submitted with the bid to be further considered. The City shall be the sole authority to determine adequacy of proposed equipment.
- 4.5.4 The contractor shall assume liability for all applicable local, state, and federal laws including, but not limited to, environmental regulations related to the transportation and disposal of the tires.
- 4.5.5 The contractor agrees to hold the City of Savannah harmless from any and all legal action that may result from the contractor's action in handling the tires.
- 4.6 City Servicing Locations

The City reserves the right to add, move, or change servicing locations.

- 4.6.4 City Lot 702 Stiles Avenue Savannah, GA 31415
- 4.7 This is an annual contract. Prices shall remain firm. This agreement may be renewed for up to four additional twelve month periods, if all contracting parties so agree and services provided by the vendor have been satisfactory. The first term of this contract shall begin upon award and shall end on December 31, 2019. All remaining renewal options, if exercised, shall begin on January 1 and end on December 31 of each subsequent year.
- 5.0 General Conditions
- 5.1 The bid response shall include all documents required in the bidder's checklist.

All referenced documents must be completed and returned in their entirety to constitute a complete bid.

- 5.5 This contract will be awarded to the vendor offering the lowest net price to the City, and meeting or exceeding all specifications herein.

# Instruction for Completing Systematic Alien Verification for Entitlement (SAVE) Form

O.C.G.A. § 50-36-1, requires Georgia's cities to comply with the federal **Systematic Alien Verification for Entitlements (SAVE) Program**. SAVE is a federal program used to verify that applicants for certain "public benefits" are legally present in the United States. Contracts with the City are considered "public benefits." Therefore, the successful bidder will be required to provide the Affidavit Verifying Status for City of Savannah Benefit Application prior to receiving any City contract. The affidavit is included as part of this bid package but is only required of the successful bidder.
