Security Plan for Alcoholic Beverage License, Ancillary Retail Package Store – selling wine by the bottle only

The Salt is a Specialty Retail Store focusing on our own line of salts, seasonings, teas as well as other Georgia produced jams, sauces, coffee, peanuts, snacks and wine by the bottle. There is one entry/exit door that opens directly on to the West Bryan Street and faces Ellis Square. It is approximately 800 square feet.

1. **Identification of days and hours of operation:** Hours of Operation: Hours of operation - we will be open Monday through Saturday from 10:00 a.m. to 6:00 p.m. and Sunday from 11 a.m. to 5:00 p.m.
2. **Specific measures and procedures to address crowd management both inside and outside the premise:** We will limit customers inside the space (which is about 800 square feet). There is one entrance/exit from the street.
3. **Identification of any parking areas owned or controlled by establishment:** The store is located at the Andaz Hotel Building facing Ellis Square. Our store is between the Andaz main entrance and the entrance to the Whitaker Parking Garage. There is very limited on street parking, but ample parking in Whitaker Parking Garage.
4. **Means of controlling access to the premises and parking area:** Most customers are coming in to buy our primary products, which are salts, seasoning blends, local jams, jellies and sauces. Sales of Georgia produced wine by the bottle will probably be less than 10% of the total sales of the store.
5. **Security Staffing:** We will have dedicated cameras in our store to monitor activity (not installed yet but have purchased the system from SimpliSafe).
6. **Measures used to combat underage consumption of alcoholic beverages:** Our company policy is that we see the valid picture ID of any person purchasing wine by the bottle from us. We also have a visual sign to indicate the correct date for the legal age to buy alcohol at the POS. Each employee working in the store will be certified completing the Responsible Alcohol Server Training course.
7. **Measures used to distinguish between patrons who are over and under the age of 21, where applicable:** All Salt Table employees are required to take the alcohol server training course and we ID every person who purchases alcohol. We will only sell unopened wine in factory sealed bottles.
8. **Measures and procedures to combat the risk of fire:** Our store is a non-smoking facility and so we do not have any reason to put measures into place to ensure there are no accidental fires. Outside our store is cement sidewalk, street pavement and the building is stucco and brick, so there is very little to burn.
9. **Discuss matters related to managing emergencies, such as fires, evacuation tactics, assignment of employee duties during emergencies, and coordination with public safety:** In the event of an emergency, The Salt Table staff will have the customers exit the store and call 911.
