Both vendors are being awarded a partial amount as one item bid by JDX did not meet specifications and was awarded to the lowest responsive, responsible bidder. These items will be used by the Savannah Police Department to outfit officers and maintain quartermaster storeroom inventory.</p> <p>Proposals were originally received on March 1, 2016. The original contract was approved in Council on May 12, 2016. This is the first of four renewal options available. Delivery: As needed. Terms: Net 30 days.
