SPECIFICATIONS AND SPECIAL CONDITIONS

4.0 The purpose of these specifications is to describe requirements for street repair and street resurfacing for the City of Savannah. The repairs portion of the contract will supplement work done by City crews and will be used during excessive workload times, and/or emergency situations and when repair complexity exceeds the City's resources. The resurfacing portion of this contract will be utilized to resurface approximately five to ten miles of City streets annually.

Sealed proposals for this event will be received by the City of Savannah in the office of the Purchasing Director, 305 Fahm Street, Savannah, Georgia 31401 until 1:30PM (EST) on Tuesday, December 10, 2019. The Disadvantaged Business Provisions will be evaluated and those bids found to be in compliance with the Disadvantaged Business Provisions shall be opened and read aloud at 1:30PM EST on Tuesday, December 17, 2019. Electronic responses will not be accepted for this event.

A pre-bid conference has been scheduled to be conducted at the Purchasing Office, 305 Fahm Street, Savannah, Georgia 31401. This meeting will allow contractors to discuss the specifications and resolve any questions and/or misunderstandings that may arise with City staff. You are invited to attend.

- 4.1 Specifications
 - 4.1.1 All asphalt shall be placed such that each compacted layer conforms to Table 1: Asphalt Types. Unless otherwise approved by the Director of Mobility Services or a designated representative, asphalt type may not be substituted when paving deep lift situations. For example, a six inch deep excavation would require the placement of four inches compacted thickness of 19 mm, and two inches compacted thickness of 12.5 mm asphalt.

- 4.1.2 In all cases, the City representative will describe the work, location, and timing requirements involved. A mutually agreed upon approach will be determined for each job.
- 4.1.3 The contractor will provide all materials, labor, equipment, and supervision required to complete the work. All materials must comply with current City of Savannah specifications.
- 4.1.4 The contractor will be responsible for any and all damages that result from repair work performed.

- 4.1.5 The City reserves the right to award this contract to a primary, secondary, and tertiary vendor if deemed advantageous.
- 4.1.6 The contract will be awarded based on price, qualifications, experience, and responsiveness. These factors will be considered and the City will be the sole judge as to the relative merits of each bidder.
- 4.1.7 On any specific job, the City reserves the right to solicit estimates from the secondary and/or tertiary vendor. The City also reserves the right to solicit bids outside of this contract for specific jobs if deemed appropriate.
- 4.1.8 The contractor shall be responsible for obtaining all required permits, including City of Savannah rights-of-way work permits.
- 4.1.9 On repair projects, response time shall not exceed 72 hours from notification. Response time is defined as having manpower and equipment on site ready to begin work. The response time specified includes weekends and holidays.
- 4.1.10 The successful contractor must provide a 100% non-prorated warranty for the period of one year. Defects will be repaired within 10 calendar days of notification. If not repaired within the prescribed time frame, the City will have the correction made at the contractor's expense.
- 4.1.11 Site establishment: This item shall include all costs involved with the mobilization to the designated site, and demobilization from the site.
- 4.1.12 Site determination/invoicing: Multiple sites within 300 linear feet of a centrally located repair site shall be deemed a single site and shall be invoiced at the aggregate tonnage. Single site status to be determined by the Director of Mobility Services or designee.
- 4.1.13 Quality assurance: The successful bidder shall measure and record the temperature of the asphalt placed at each individual location. If density testing is needed, the site specific to be determined by the Director of Mobility Services or designee. Quality control is the responsibility of the contractor.
- 4.1.14 Disposition of spoils, demucked material, millings, etc.: Any and all material that can be reclaimed or recycled shall be transported to a location designated by the Director of Mobility Services or designee. Millings shall be delivered to the city at a designated site at a rate of 25% per total volume.
- 4.1.15 Verifiable experience and bonding

The bidding contractor must have 10 years of verifiable experience in resurfacing in high traffic and historical areas such as major arterials, collectors, and freeways. Also, the bidding contractor must be bondable in the amount of the contract awarded. A letter from Surety or Insurance bond shall be included in the bid.

- 4.2 Utility Excavations Equipment Required
 - 4.2.1 Bituminous distributor: The distributor shall have pneumatic tires of such width and number that the load produced on the base surface shall not exceed 650 pounds per inch of tire width. It shall be so designed and equipped as to distribute the bituminous material uniformly at even heat in variable widths of surface at readily determined and controlled rate ranging from 0.05 to 2.0 gallons per square yard, with a pressure range of from 25 to 75 pounds per square inch and with an allowable variation from any specified rate not exceeding 10 percent (10%). Distributor equipment shall include an independently operated bitumen pump, tachometer, pressure gauges, volume measuring devices, a thermometer for reading the temperature of tank contents, and a hose attachment suitable for applying bituminous material to spots missed by the distributor. The distributor shall be equipped for circulation and agitation of the bituminous material during the heating process.

- 4.2.2 Bituminous-materials spreaders: Shall be self-propelled type equipped with hoppers, tamping or vibrating devices, distributing screws, adjustable screeds, equipment for heating the screeds, and equalizing devices. The spreader shall be capable of spreading hot bituminous mixtures without tearing, shoving or gouging, while producing a smooth finished surface, confining the edges of the strips to true lines without the use of stationary side forms and placing the course to the required thickness. Spreaders shall be designed to operate forward at variable speeds and in reverse at traveling speeds of not less than 100 feet per minute. The use of a spreader that leaves indented areas or other objectionable irregularities in the fresh-laid mix during operation will not be permitted.
- 4.2.3 Steel-wheel rollers: Shall be the self-propelled, three-wheel and tandem types. The three (3) wheel rollers shall have a minimum weight of 300 pounds per inch of width in the rear wheel. The wheels shall be equipped with adjustable scrapers, water tanks sprinkling and apparatus that will be used for keeping the wheels wet to prevent the bituminous mixture from sticking to the wheels. The rollers shall be capable of reversing without backlash and shall be free from worn parts. The roller wheels shall have no flat or pitted areas and no projections that will leave marks in the pavement. Three-axle tandems will be permitted in lieu of two-axle tandems if accepted by the Engineer.
- 4.2.4 Heavy pneumatic-tired rollers: Shall be self-propelled and shall consist of two axles on which are mounted multiple pneumatic-tire wheels in such a manner that the rear group of wheels will not follow in the tracks of the forward group but will be so spaced as to give essentially uniform coverage with each pass. The axles shall be mounted in a rigid frame provided with a loading platform or body suitable for ballast loading. The tires shall be smooth and shall be capable of being inflated to a minimum pressure of 90 pounds per square inch. Construction of the roller shall be such that each wheel can be loaded to a minimum of 4,500 pounds.
- 4.2.5 Light pneumatic-tired rollers: Shall consist of two axles on which are mounted not less than nine pneumatic-tired wheels in such manner that the rear group of tires will not follow in the tracks of the forward group, but will be so spaced as to give essentially uniform coverage with each pass. The axles shall be mounted in a rigid frame provided with a loading platform or body suitable for ballast loading. The tires shall be uniformly inflated. The rollers shall be weighted with not less than 4.5 tons of ballast. The tractor and other towing equipment shall also be equipped with pneumatic tires. The tires on both rollers and towing equipment shall be smooth and of a type that will not leave tire prints in the surface being rolled. The use of a self-propelled roller meeting the above requirements will be permitted.
- 4.2.6 Blowers and brooms shall be of the power type and shall be suitable for cleaning the surface to be paved.
- 4.2.7 Small tools: Shall consist of rakes, lutes, shovels, tampers, smoothing irons, pavement cutters, portable heater for heating small tools, wood sandals, stilt sandals of standard type, and other small tools, as may be required. A sufficient number of small tools shall be available at all times for use in constructing the bituminous pavements efficiently. The lutes shall be constructed of metal and shall consist of a plate or sheet 36 by four inches, attached to a handle properly braced and with sufficient strength to adequately compact the free edge of the surface course. Hand tampers shall weigh not less than 25 pounds and shall have a tamping face not larger than 50 square inches.
- 4.3 Mixing plants: Asphaltic concrete shall be mixed in central plants conforming to the applicable requirements of Section 400 of the Standard Specifications of the Georgia State Highway Department.
- 4.4 Transportation of bituminous mixture: Transportation of bituminous mixture shall be from the paving plant to the site in trucks having tight, clean, smooth beds that have been coated with a minimum amount of a concentrated solution of hydrated lime and water to prevent adhesion of the mixture to the truck bodies. Each load shall be covered with canvas or other accepted material of ample size to protect the mixture from the weather and to prevent loss of heat. Deliveries shall be made so that the spreading and rolling of all mixture prepared for one day's run can be completed during daylight, unless adequate accepted artificial lighting is provided. The mixture shall be delivered to the area to be paved in such manner that the temperature at the

time of dumping into the spreader will not be less than 235 degrees F. Any loads that are below minimum temperature, that have crusts of cold unworkable material or that have been wet excessively by rain will be rejected. Hauling over freshly laid material will not be permitted.

- 4.5 Placement of Asphaltic Concrete
 - 4.5.1 Surface preparation of underlying course: Prior to the laying of the surface course, the underlying base shall be cleared of all foreign or objectionable matter with power blowers, power brooms, or hand brooms, as directed.
 - 4.5.2 Bituminous tack coat: Prior to placement of "F" Mix asphalt, each location shall be sprayed with Tack Coat AC-20 or AC-30. Bituminous material for the tack coat shall be applied in quantities from 0.05 to 0.08 gallon only to exceed 0.10 gallon on milled surfaces per square yard at a minimum of 350 degrees. The entire surface to be paved shall be coated with the tack coat. The tack coat shall only be applied when the base is dry and when the temperature has not been below 35 degrees Farenheit for 12 hours immediately prior to the application. The tack coat shall only be applied when the temperature of the air in the shade is 55 degrees Fahrenheit or above. When the temperature in the shade is 70 Fahrenheit or above, an emulsion such as CRS-2h or CRS-3 may be used.
 - 4.5.3 Surface Course: The surface course shall be laid in one course. Unless otherwise specified the surface course shall be a two-inch depth type "F" asphaltic concrete consisting of fine and course aggregate and mineral filler uniformly mixed with hot asphalt cement in a central mixing plant. An anti-stripping agent shall be added to the asphalt-cement in the preparation of the hot-mix asphalt concrete when hydrophilic aggregates are used. All asphalt placed shall conform to the latest Georgia Department of Transportation Specifications.

Tolerances: The surface shall be finished to match existing grade, with a maximum deviation of +1/4 to -0 inches when measured with a 10 foot straight edge in any given direction (excluding crown).

- 4.5.4 General requirements for use of mechanical spreader: If area to be patched is over 12 feet in length, mechanical spreader will be required. Asphalt mixtures having temperature less than 235 degrees F. when dumped into the mechanical spreader will be rejected. The mechanical spreader shall be adjusted and the speed regulated so that the surface of the course will be smooth and continuous without tears and pulling, and of such depth that, when compacted, the surface will conform with the cross section, grade, and contour indicated. Unless otherwise directed, the placing shall begin along the centerline of areas to be paved on a crowned section or on the high side of areas with a one way slope, and shall be in the direction of the major traffic flow. The mixture shall be placed in consecutive adjacent strips having a minimum width of 10 feet, except where the edge lanes require strips less than 10 feet to complete the area. Each strip laid before a succeeding strip shall be of such a length that sufficient heat will be retained to make the strip readily compactable so that a joint can be obtained that will conform to the requirements for texture, density, and smoothness.
- 4.5.5 Shoveling, raking, and tamping after machine spreading: A sufficient number of shovelers and rakers shall follow the spreading machine adding or removing hot mixture and raking the mixture as required to obtain a course that when completed will conform to all requirements specified herein. Broadcasting or fanning of mixture over areas being compacted will not be permitted. When segregating occurs in the mixture during placing, the spreading operation shall be suspended until the cause is determined and corrected. Any irregularities in alignment left by the mechanical spreader shall be corrected by trimming directly behind the machine. Spreader shall be corrected by trimming directly behind the machine. Spreader shall be course shall be thoroughly compacted by tamping liberally with the metal lute specified herein. Distortion of the course during tamping will not be permitted.
- 4.5.6 Hand spreading in lieu of machine spreading: In areas where the use of machine spreading is impractical, the mixture shall be spread by hand. The mixture shall be dumped on acceptable dump boards or at an adjacent acceptable area outside the area to be paved and shall be distributed into

place from the dump boards or from the acceptable area by means of hot shovels. The mixture shall be spread with hot rakes in a uniformly loose layer of a thickness that, when compacted, will conform to the required grade and thickness. During hand spreading, each shovelful of mixture shall be carefully placed by turning the shovel over in a manner that will prevent segregation. In no case shall the mixture be placed by throwing or broadcasting from a shovel. The loads shall not be dumped any faster than can be properly handled by the shovelers and rakers. Rakers not equipped with stilt sandals shall not be permitted to stand in the hot mixture while raking the course.

- 4.5.7 Protection of pavement: After final rolling, no vehicular traffic of any kind shall be permitted on the pavement until the pavement has cooled and hardened and in no case, less than six hours.
- 4.5.8 Compaction of mixture: Compaction of mixture shall be effected by the three-wheel rollers, the tandem rollers, the light pneumatic-tired rollers and the heavy self-propelled pneumatic-tired rollers, specified herein before. Rolling of the mixture shall begin as soon after placing the mixture will bear the roller without undue displacement. Delays in rolling freshly spread mixture will not be tolerated. The rolling shall continue until the surface mixture is compacted to a minimum 100% density of AASHTO T-230. Compaction rolling shall be compacted before the surface temperature drops below 185 degrees F. Field density will be determined by AASHTO T-191 or T238.
- 4.5.9 Patching deficient areas: Any mixture that becomes contaminated with foreign material or is in any way defective shall be removed. Skin patching of an area that has been rolled will not be permitted. Holes of the full thickness of the course shall be cut so that the sides are perpendicular and parallel to the direction of traffic and so that the edges are vertical. Edges shall be sprayed with tack coat bituminous materials. Fresh paving mixture shall be placed in the holes in sufficient quantity so that the finished surface will conform to grade and smoothness requirements. The paving mixture shall be compacted to the density specified herein. The contractor shall provide competent workmen capable of performing all work incidental to correction of deficiencies and defects.
- 4.6 Detailed Specifications Street Resurfacing
 - 4.6.1 Approximately five to 10 miles of City streets will be resurfaced. Some of the streets will be selectively milled. The streets to be milled will be determined after bid award but the estimated quantity involved is shown on the bid proposal form.
 - 4.6.2 Unit prices are to include cost for mobilization, normal traffic control, raising of manhole rings/covers, raising of existing water valve collars, and striping/makings.
- 4.7 Streets included in the resurfacing contract shall be determined by the Director of Mobility Services or designee.

4.9 Petrotac Paving Strip

Pertotac paving strip membrane #4591, 50 pounds/in meeting strip tensile strength ASTM-D882 (modified) with a puncture resistance of 200 pounds (ASTM-b-154). Roll size shall be two feet in width and 108 feet in length with a gross weight of 90 pounds manufactured by Amoco Fabrics and Fibers Company, 260 The Bluffs, Austell, Georgia 31168 Phone 770-944-4569.

- 4.10 Pavement Markings
 - 4.10.1 All existing roadway markings shall be restriped as currently marked at existing locations. All existing roadway markings on side roads shall be restriped the end of the new resurfaced section. Marking shall meet current Georgia Department of Transportation (GDOT) standards, details available upon request.
 - 4.10.2 Temporary striping is required in accordance with GDOT Specifications, Section 150.2.08 and 150.3.10. Placement of permanent markings shall not begin until final surface course has been completed for 15 calendar days.

4.11 Traffic Signal Loop Replacement

All vehicle loop replacement work shall conform to the appropriate sections of GDOT specifications, Section 647 and Section 925. The location of the replacement loop detectors, where practical, shall coincide with original location. Loop testing and acceptance shall be provided by Traffic Engineering Superintendent or designee.

4.12 Public Safety and Convenience

All work done under this contract shall be done in compliance with GDOT Guidelines and the Manual on Uniform Traffic Control Devices (MUTCD)-latest revisions. Each operation shall be considered a work zone area and shall be treated in accordance with the MUTCD.

- 4.12.1 Contractor shall provide signs, barricades, fences, lights, etc., for protection of property and the public as required by the MUTCD. The contractor will be held liable for all damage to property and/or persons.
- 4.12.2 Flow of traffic shall not be interrupted completely without the approval of the Mobility Services Director or designee. Restriction and minor diversion will be kept to a minimum. No work will be permitted in the traffic lanes during peak hours, 7:00 AM to 9:00 AM and 4:00 PM to 6:00 PM, Monday through Friday, unless approved in advance by the Mobility Services Director or designee.
- 4.12.3 Appropriate personal protective equipment shall be worn by all contract personnel when on the job-site.

4.13 Insurance Requirements

Insurance Requirements are non-negotiable.

4.13.1 Comprehensive General Liability

Contractor shall carry comprehensive general liability on an occurrence form with no "x, c or u" exclusions with the following minimum limits:

- Each occurrence \$1,000,000
- Damage to Rented Premises \$50,000
- Medical Expense \$5,000
- Personal & Adv. Injury \$1,000,000
- General Aggregate \$2,000,000
- Products Completed Ops. Aggregate \$2,000,000

General aggregate shall apply on a per project basis.

Contractor will provide a Certificate of Insurance reflecting required coverage.

A waiver of subrogation endorsement to the policy in favor of the City shall also be provided and attached to the certificate.

A (30) day notice of cancellation in favor of the City must be endorsed to policy and attached to the certificate.

4.13.2 Commercial Automobile Liability

The automobile policy must include coverage for owned, non-owned and hired automobiles

- Minimum limits are \$1,000,000
- Contractor will provide a Certificate of Insurance reflecting required coverage.
- A waiver of subrogation endorsement to the policy in favor of the City shall also be provided and attached to the certificate.
- A (30) day notice of cancellation in favor of the City must be endorsed to policy and attached to the certificate.

4.13.3 Workers Compensation

Contractor shall carry a workers compensation policy including all statutory coverage required by Georgia state law.

Minimum employer's liability limits:

- \$500,000 each accident
- \$500,000 each employee (disease)
- \$500,000 policy limit (disease)

Contractor will provide a Certificate of Insurance reflecting required coverage.

A waiver of subrogation endorsement to the policy in favor of the City shall also be provided and attached to the certificate.

A (30) day notice of cancellation in favor of the City must be endorsed to policy and attached to the certificate.

4.13.4 Umbrella/Excess Liability

Contractor shall carry an umbrella/excess liability policy which must follow form over underlying policies: general liability, auto liability and employer's liability.

Minimum limits:

- \$1,000,000 per occurrence
- \$1,000,000 aggregate

Contractor will provide a Certificate of Insurance reflecting required coverage.

Waiver of subrogation endorsement to the policy in favor of the City shall also be provided and attached to the certificate.

A (30) day notice of cancellation in favor of the City must be endorsed to policy and attached to the certificate.

4.14 Satisfaction of LDBE Goals; Good Faith Effort

The City of Savannah has established a 20% LDBE goal for this project of which at least 10% must be met by a Local DBE.

The process by which the City determines whether an Offeror has met the City's LDBE goal is set forth in the guidelines below:

- a. A bid shall be considered non-responsive unless a bidder meets either the LDBE goal established for the contract or demonstrates good faith effort to meet the LDBE goal.
- b. In order to meet the LDBE goal of a solicitation, a bidder entity must submit the following information:
 - i. The names and addresses of each LDBE that will participate in the contract;
 - ii. A description of the work that each LDBE will perform;
 - iii. The percentage of the contract value that each LDBE will receive.
 - iv. Written documentation, in a form acceptable to OBO, of the bidder's commitment to use each LDBE whose participation the bidder submits to meet the contract goal; and
 - v. Written confirmation, in a form acceptable to OBO, from each LDBE that it will participate in the contract as indicated by the bidder.
- c. The bidder should submit the above information as follows:
 - i. Under sealed bid procedures, the information should be provided with the sealed bid response; or
 - ii. Under requests for letters of interest or requests for proposals, the information should be provided with the initial letter of interest or proposal.
- d. If the information required by section (b) above is not provided in accordance with section (c) above, the information must be provided to the City of Savannah within three business days after OBO notifies the bidder that it has not provided all the required information with its response. Failure to provide the City of Savannah with this information within such three business days may be cause for the response to the solicitation to be deemed non-responsive.
- e. Determination of Good Faith Effort.
 - i. A bidder shall not be denied award of a contract due to failure to meet the assigned contract goal if the bidder timely (within the timeframes provided in paragraphs (c) and (d) above, as applicable) provides documentation demonstrating the bidder's good faith effort to meet the goal, as determined by the Program Coordinator. In making such determination, the Program Coordinator shall consider the quality, quantity, and extent of the various efforts that the bidder has made to meet the goal.
 - ii. The efforts that may be considered by the Program Coordinator include, but are not limited to:

- 1. Soliciting through activities such as attendance at pre-bid meetings, advertising, or written notices, the interest of certified LDBEs (or LDBEs eligible for certification) that have the ability and capacity to perform the contract work. The bidder must solicit this interest in a timely manner to allow the LDBEs to respond to the solicitation. The bidder must take appropriate steps to follow up initial solicitations of LDBEs.
- 2. Identifying the portions of the contract that could reasonably be performed by a LDBE in order to increase the likelihood that the LDBE goals will be achieved. This may include, where appropriate and commercially practicable, separating contract work items into segments more appropriate for participation by LDBEs.
- 3. Providing each interested LDBE with adequate information about the plans, specifications, and requirements of the contract in a timely manner.
- 4. Negotiating in good faith with each interested LDBE. Evidence of such negotiation includes the names, addresses, and telephone numbers of LDBEs that were considered; a description of the information provided regarding the plans and specifications for the work selected for subcontracting; and explaining why an agreement could not be reached with an interested LDBE to perform the work. The fact that there may be some additional costs involved in subcontracting with LDBEs is not in itself sufficient reason for a bidder's failure to meet the contract LDBE goal, as long as such additional costs are reasonable, as determined by the Program Coordinator in his or her sole discretion.
- iii. In determining whether a bidder has made a good faith effort, the Program Coordinator may also consider the level of participation proposed by the bidder and the level of participation proposed by other bidders. The closer the bidder's proposed participation is to the goal or to the proposed participation by other bidders, the greater the indication of good faith by the bidder.

4.15 Hire Savannah Program Participation

- 4.15.1 The City of Savannah seeks to increase the utilization of the local workforce to the greatest extent possible on City contracts. To achieve this priority, the City of Savannah Mayor and Aldermen endorse efforts to establish hiring agreements with businesses benefitting from municipal contracts with the City to hire local workers residing in the city of Savannah, Georgia.
- 4.15.2 To the extent otherwise permitted by law, the requirements of the Hire Savannah Program shall be included in all bid awards of \$100,000 or more for covered services and \$250,000 or more for construction-related services as a method of inducing contractors to hire qualified workers who reside in Savannah, Georgia.
- 4.15.3 To assist contractors in maximizing local labor use, the City of Savannah has partnered with WorkSource Coastal (WSC). WSC assists employers and job seekers in meeting job training and employment needs throughout the ten county coastal region including Savannah and Chatham County. WSC will post contractor job openings, coordinate recruitment among partner agencies, and refer qualified candidates to contractors for hiring consideration. Additional employer services are also available through WSC, including federally-subsidized training and/or wages for eligible activities.
- 4.15.4 The Contractor is fully responsible for the work performed under the contract, and this responsibility is not in any way diminished by the use of labor supplied by WSC, nor is the City of Savannah or WSC

accepting any responsibility for non-compliance with the contract due to the performance, or lack thereof, on part of labor supplied by WSC.

- 4.15.5 The Contractor is responsible for the compliance of all contractors providing services under the Covered Contract, including subcontractors and lower-tier subcontractors but excluding material manufacturers and suppliers, with the requirements of the Hire Savannah Policy.
- 4.15.6 In responding to this solicitation, the bidder/proposer shall complete a Hire Savannah Agreement, indicating that it agrees to be bound to contractual obligations to use good faith efforts to meet Hire Savannah Program requirements and hire Qualifying Workers residing in Savannah, Georgia.
- 4.15.7 If the bidder or proposer fails to respond affirmatively, it shall be deemed non-responsive to the solicitation.
- 4.16 This is an annual contract. Prices shall remain firm. This agreement may be renewed for up to four additional 12 month periods, if all contracting parties so agree and services provided by the vendor have been satisfactory. The first term of this contract shall begin upon award and shall end on December 31, 2020. All remaining renewal options, if exercised, shall begin on January 1 and end on December 31 of each subsequent year.
- 4.17 In the event that the primary contractor fails to meet the above response requirements, the City may contact the secondary and tertiary contractors as necessary at the sole discretion of the City and immediately proceed with the execution of the work.
- 4.18 Qualifications/References

The vendor must be able to demonstrate the successful completion of projects with a similar scope of work. The vendor shall supply a minimum of three references (including Company name, contact person and phone number) for whom he has completed similar projects. Refer to Attachment 1 for jobsite superintendent requirements.

- 5.0 General Conditions
- 5.1 The bid response shall include all documents required in the bidder's checklist. All referenced documents must be completed and returned in their entirety to constitute a complete bid.
