# Requirements for naming newly created, acquired, or unnamed property. (Sec.4-1102)

## Criteria Requirement met by request

- ✓ To honor and commemorate noteworthy persons
- ✓ To strengthen neighborhood identity

### Restrictions

- ✓ Person must reside within the City of Savannah for minimum of 5 years
- ✓ Names assigned to existing public property within the City or unincorporated Chatham County where duplication of the name is likely to lead to confusion; and
- ✓ Except as set forth in Section 4-1106, commercial names where usage of such name would amount to advertising.

# Considerations

- ✓ The number of residents and businesses directly affected;
- ✓ Community diversity;
- ✓ The historical significance of preexisting name or location;
- ✓ The appropriateness and compatibility of the request in relation to the existing area:
- ✓ The impact on emergency service delivery; and
- ✓ Continuity and stability.

# Natural Person Naming Request

✓ Proposed honoree for permanent naming should be deceased


✓ Honoree should have demonstrated a sustained contribution over a period including but not limited to leadership, community development, cultural or historical affairs, humanitarian efforts or governmental service.

# **Ridgewood Extension Subdivision and Park**




Revised Plan with Topography of Ridgewood Extension, A Subdivision of Land in Chatham County, Georgia. Surveyed for Southwood Corporation, October 15, 1947." Chatham County Engineering Department, Plat 120.

Ridgewood Extension Subdivision was laid out by the Southwood Corporation in 1947 and the subdivision completed the local government approval process on January 9, 1948. The area was annexed into the City of Savannah in 1950. The 1947 subdivision plat held by the Chatham County Engineering Department (Plat 120) indicates a rectangular unnamed park at the intersection of Atlantic Avenue and 66<sup>th</sup>. Historical maps in the City of Savannah Municipal Archives' collections also show this park as unnamed after it was annexed into the City limits. In the current Savannah Area Geographical Information System (SAGIS), the park is labeled as "Lamara Heights Park." On Google Maps, the park is labeled as both "Candler Park" and "Lamara Heights Park." No record of a naming action as been identified to date in the City's official records


