## AN ORDINANCE To Be Entitled

AN ORDINANCE TO AMEND PART 8, CHAPTER 3, ZONING, TO ESTABLISH A MICROBREWERY USE IN THE TC-1 (TRADITIONAL COMMERCIAL-1) AND TC-2 (TRADITIONAL COMMERCIAL-2) ZONING DISTRICTS AS A SPECIAL USE; TO ESTABLISH USE CONDITIONS FOR SUCH USE; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in regular meeting of Council assembled and pursuant to lawful authority thereof:

- (a) Such use shall be located on an arterial street as identified in Sec. 8-3025(g), Street Classification Map;
- (b) Such use shall be restricted to a production of up to 3,000 barrels of beer/ale per year.
