Enforcement

ENFORCEMENT AUTHORITY

- City Ordinance "Sec. 4-1017. Trains not to block streets for more than ten minutes".
- City and State is preempted by Federal Law under Federal Railroad Safety Act, Interstate Commerce Act, and US Commerce Clause.





Short-Term Actions

Mitigating the Impact

- 1. Reduce the train crossings during 'rush hour' timeframes.
- 2. Collect and record data on impact of train crossings.
- 3. Communicate and promote working relationship with GITW. (Golden Isles Terminal Wharf)



Long-Term Solutions

- Explore more efficient switching and delivery options
 - Meeting scheduled in May 2019 with CSX
- Construct overpass for vehicular traffic
 - Included on 2012 TSPLOST ballot
 - \$130 million dollars

Quiet Zone

- Feasibility study completed by City staff
 - 22 rail crossings, 10 without SSMs
 - Improves Quality of Life
 - Promotes Continual Economic Growth
 - Capital cost, \$7 million*
 - Recurring Maintenance Cost, \$140,000*
 - Absorbed Liability
- Regional problem needs regional solution
 - Grants
 - Cost sharing
