BOARD APPOINTMENTS

23. Mayor Eddie DeLoach Nominates Mr. Joseph N. Bell Jr. to be Reappointed to the Downtown Savannah Authority for a Four-Year Term Ending May 31, 2023 (City Resident)

Alderman Johnson moved to approve Item #17, Alderman Durrence seconded. The motion carried 5-2-1. Aldermen Thomas and Shabazz voted no. Mayor Pro-Tem Bell recused herself.

Alderman Thomas requested to be read into the record what the Downtown Savannah Authority responsibilities are and what they do. Clerk of Council read, "The Downtown Savannah Authority has five (5) members, including Mayor or member of City Council serving his/her term of office and four (4) City residents appointed to 4-year terms by City Council, as well as a member of Chatham County Delegation to the GA Legislature. Encourages construction of new parking facilities and provides financial incentives for private projects which have economic benefits to the downtown area".

Alderwoman Dr. Shabazz wanted it noted in the public record the reason why she voted 'no' on Item #17, there was no discussion among Council Members nor during public meeting.

24. Mayor Eddie DeLoach Nominates Ms. Lisa Watson to Replace Mr. Eli P. Karatassos on the Savannah-Chatham County Historic Sites and Monuments Commission for a Five-Year Term Ending July 1, 2024

Motion a. Alderman Johnson moved to approve Item #18, Alderman Foster seconded. No vote was taken.

Motion b. Alderman Miller moved to approve Item #18, Mayor Pro-Tem Bell seconded. The motion carried, 8-0-1. Alderman Durrence recused himself.

ALCOHOL LICENSE HEARINGS

25. Show Cause Hearing for Revocation of the Alcohol License for Dharrnisthaben Patel of the Marathon Gas Station at 1816 Montgomery Street (Aldermanic District 2)

Mayor DeLoach opened the Public Hearing for Item #19. Speakers:

Assistant City Attorney Denise Cooper presented the show cause hearing for revocation of the alcohol license with the following three (3) witnesses for the City.

- -Ms. Judee Jones of the Revenue Department answered questions from Attorney Cooper regarding the applications received for 1816 Montgomery Street. She gave dates of the original application in 2018 which was not approved and then there was a reapplication in 2019 of the same applicant with a new address.
- -Mr. Michael Chaney of the Code Compliance Department answered question from Attorney Cooper as to the environment surrounding the location and the condition of the property and code violations.
- Lt. Jones of the Savannah Police Department answered questions from Attorney Cooper concerning the prior owners and the problems at the location. There have been problems with loitering, drinking and several drug related calls with the prior owners as well as the current owners. Lt. Jones cited 14 drug related calls during 2018 with 11 arrest and indictments. In 2019 there were 7 drug related calls through March 9, 2019 plus a search warrant. The owners submitted a security plan and application to the police department and said they would put up signs for no loitering. Lt. Jones indicated the same individuals who were owners in 2018 are the owners in 2019 and were warned of the frequent drug activities.

Attorney Steve Scheroff spoke on behalf of the current owners and the proposed incidents that had no dates or reports. He also questioned each witness as to their responsibilities in giving reports to the owners.

Following the three (3) witnesses testimony, there was discussion, comments, and questions by Aldermen, Attorney Sheroff, Lt. Jones and Attorney Cooper. Motion a. Alderman Johnson moved to close the public hearing, Alderman Hall seconded. The motion carried unanimously.

Motion b. Alderman Hall moved to approve Item #19 supporting the recommendation to revoke the alcohol license by attorney and staff, Alderman Durrence seconded. Alderman Hall withdrew his motion.

Motion c. Alderman Thomas moved (a substitue motion) to approve Item #19 as amended to suspend the alcohol license for 30 days pending the development of a plan with the owner and the ABC Team to cleanup and address the issues and work with staff and attorneys to do so. After the terms are agreed upon, there will be periodic inspections. If there are any additional criminal violations beyond that 30 days, another show case hearing will be held immediately to revoke the license, Mayor Pro-Tem Bell seconded. The motion carried, 8-1-0. Mayor DeLoach voted no.

- -Bridget Lidy of Planning and Urban Design detailed the process for transferring alcohol license in the Alcohol Density Overlay area.
- -Dr. Betty Jones President of the Neighborhood Association questioned the transferring of the alcohol license in the Alcohol Density Overlay area. Mayor DeLoach explained in detail the process by owner.

28. Motion to Approve a Class C (Liquor, Beer, Wine) Alcohol License for Jeffery S. Wainwright, Jr. of Moodright's at 2424 Abercorn Street (Aldermanic District 2)

Mayor DeLoach opened the Public Hearing for Item #22. Speakers:

- -Mr. John Davis, Florist concerned with selling liquor since a church is across the street.
- -Mr. C. Grant Washington, Attorney leased the property to the church.
- -Mr. Josh Yellin against selling liquor at 2424 Abercorn.
- -Marcus Lotsom from MPC zoning approved for alcohol license/sales.

There followed discussion by staff as to the use of the building across the street being used as a church. After speaking with the owner's secretary, It was found not to be an active church. City staff indicated no business license has been issued at the location for a church.
