AN ORDINANCE TO AMEND THE OFFICIAL ZONING DISTRICT MAP OF THE CITY OF SAVANNAH, GEORGIA BY REZONING A 3.79-ACRE PROPERTY FROM THE RSF-20 (RESIDENTIAL SINGLE-FAMILY - 20) ZONING DISTRICT TO THE RMF-2-24 (RESIDENTIAL MULTI-FAMILY 2 – 24 UNITS PER ACRE) ZONING DISTRICT; TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

BE IT ORDAINED by The Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof, that:

SECTION 1: The following described property, 1032 Mohawk Street and 0 Mohawk St containing 3.79 acres more or less combined, be rezoned from their present RSF-20 Zoning District to the RMF-2-24 Zoning District based upon the criteria of suitability and community need, compatibility, consistency, and reasonable use:

Commencing from a point [X: 967884.63309 & Y: 723944.467112], located at the approximate intersection of the centerlines of Mohawk Street & Pointer Place,

Thence proceeding in a NW direction along the approximate centerline of Mohawk Street for an estimated distance of 607.8 ft. to a point [X: 967334.235625 / Y: 724202.402815], said point being, THE POINT OF BEGINNING,

Thence continuing in a NW direction along the approximate centerline of Mohawk Street for an estimated distance of 290.0 ft. to a point,

Thence proceeding in a NE direction [N 15-35-43 E] along a line for an estimated distance of 624.5 ft. to a point,

Thence proceeding in a SE direction [S 56-49-17 E] along a line for an estimated distance of 300 ft. to a point,

Thence proceeding in a SW direction [S 15-35-44 W] along a line for an estimated distance of 582.5 ft. to a point, [X: 967334.235625 / Y: 724202.402815], said point being, THE POINT OF BEGINNING.

The property is further identified by the Property Identification Numbers (PINs) as follows:

PIN(s): 20783 01014 & 20783 01015.

SECTION 2: The intent of the Chatham County-Savannah Comprehensive Plan, along with the Future Land Use Map, adopted by The Mayor and Aldermen on January 19, 2017 is met:

SECTION 2A: The Future Land Use Map currently designates the 9.14-acre property as being in the General Residential Future Land Use Category.

SECTION 2B: The General Residential Future Land Use Category is defined as “Areas with a wide range of residential uses including multi-family dwellings, attached dwellings, small lot single-family dwellings at densities greater than 10 units per gross acre”.

SECTION 2C: Section 5.10.2 of the Zoning Ordinance of the City of Savannah allows the RMF-2-24 Zoning District in the General Residential Future Land Use Category.

SECTION 3: That the requirements of Section 3.2 of the Zoning Ordinance of the City of Savannah and the law in such cases made and provided has been satisfied. An opportunity for a public hearing was afforded anyone having an interest or property right which may have been affected by this zoning amendment, said notice being published in the Savannah Morning News, on the ____ day of _____, 2019, a copy of said notice being attached hereto and made a part hereof.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

EFFECTIVE DATE: This ordinance shall be effective as of the date hereof.
