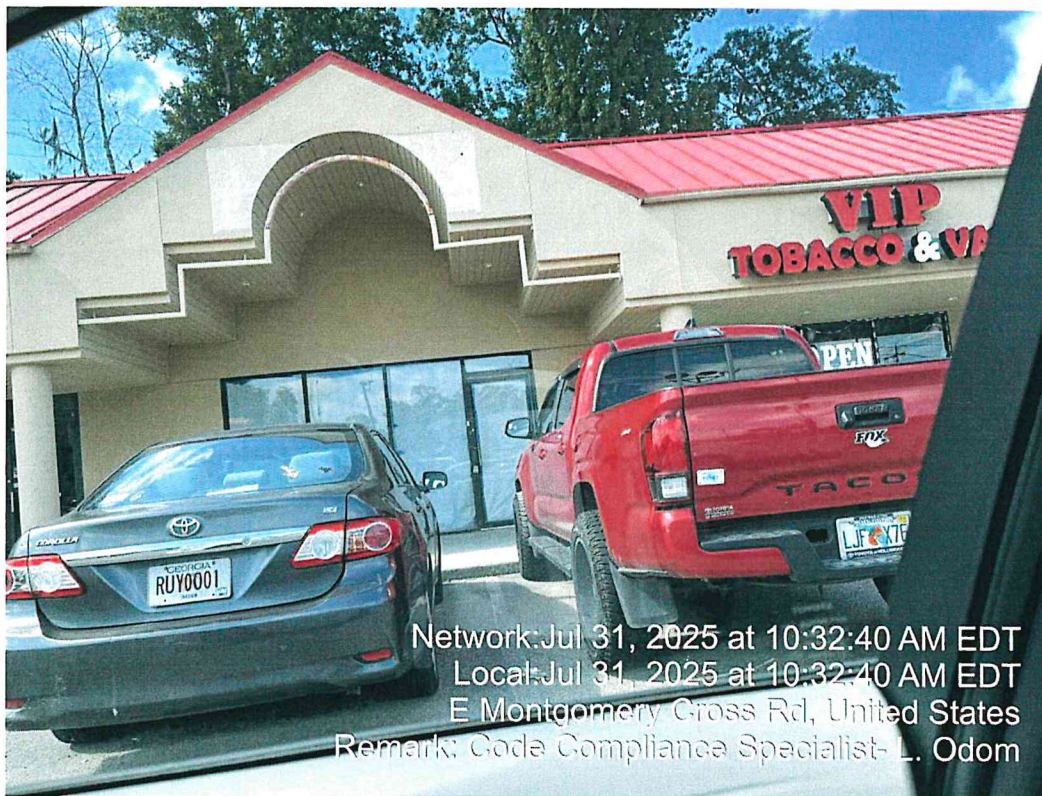

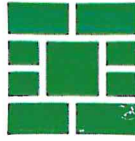

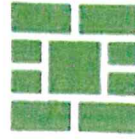

No disqualifying information found.

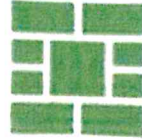
