As I mentioned, the business has a commercial dumpster behind it that has been problematic for most of my seven years here. I live directly behind the dumpster location. I have given my alderman, Detric Leggett, my proposed dumpster use and maintenance requirements to be met for that business to be awarded an alcohol license, and its commitment to meeting those requirements moving forward in order to retain the license, should it be awarded. This list of commitments can be in the form of a Good Neighbor Agreement along the lines of
