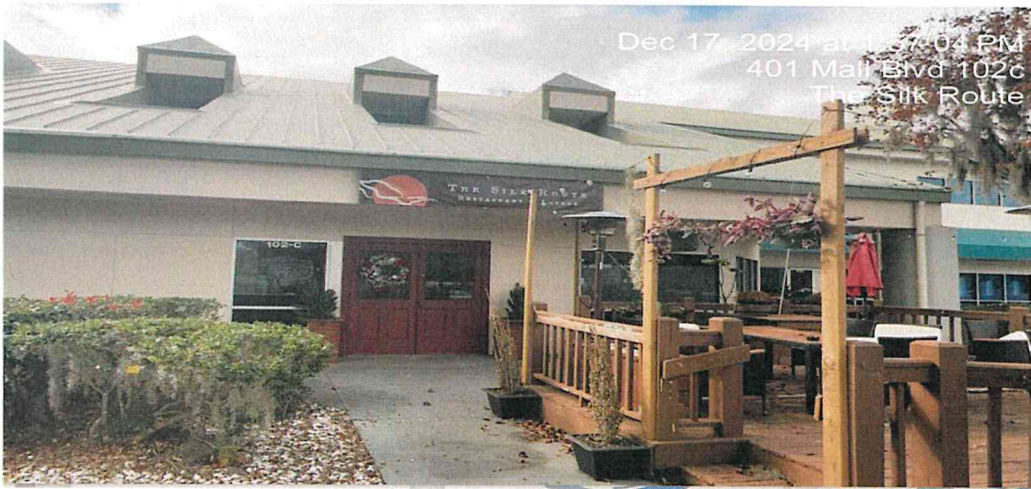

In reference to the application of **Sandeep Tamrakar, T/A Silk and Spice Restaurant & Lounge/ The Silk Route**, requesting an alcoholic beverage license at **401 Mall Blvd, Ste 102C** (PIN 20532 01003A), I have determined that the **Proposed Use, Restaurant with Accessory alcohol sales by the drink (on-premises consumption of alcohol)** within the current Community Business (B-C) zoning district:

I have determined that the **Proposed Use(s)**:

- Is Permitted by Right:** The principal use classification *Restaurant*, as defined in Article 13 of the zoning ordinance, is allowed by right in the zoning district. *Accessory alcohol sales by the drink in association with a restaurant* is permitted by right. The parcel is not within the boundaries of an Alcohol Density Overlay District.
- Is Not Permitted
- Requires a Special Use Permit from The Mayor and Aldermen
- Is Permitted as a Limited Use with Standards
- Is Permitted as a Non-conforming Use

Further, I have determined that **Parking** at the property:

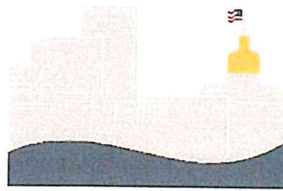
- The parking requirement is met.**

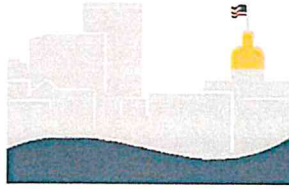
