AN ORDINANCE TO AMEND THE CITY OF SAVANNAH ZONING MAP  
AT 0 FT. ARGYLE ROAD (PIN 21033 01002) FROM B-C (COMMUNITY-  
BUSINESS) TO RMF-2-20 (RESIDENTIAL MULTIFAMILY-2-20); TO  
REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND  
FOR OTHER PURPOSES.

BE IT ORDAINED by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

SECTION 1: The following described property at 0 Ft. Argyle Road (PIN 21033 01002) be amended on the City of Savannah Zoning Map from B-C to RMF-2-20:

Commencing from a point [X: 929034.165827 & Y: 730641.72248], located at the approximate intersection of the centerlines of the eastbound lane of Fort Argyle Road/Abercorn St. & West Gateway Blvd.,

Thence proceeding in a SW direction along the approximate centerline of West Gateway Blvd. for an estimated distance of 1,248.0 ft. to a point, [X: 928625.216316 & Y: 729572.746135], said point being, THE POINT OF BEGINNING

Thence proceeding in a NE direction [N 46-52-18 E] along a line for an estimated distance of 100.2 ft. to a point,

Thence proceeding in a SE direction [S 64 -44 -53 E] along a line for an estimated distance of 421.9 ft. to a point,

Thence proceeding in a SW direction [S 38-8-44 W] along a line for an estimated distance of 1,089.3 ft. to a point,

Thence proceeding in a SW direction [S 36-58-16 W] along a line for an estimated distance of 417.2 ft. to a point,

Thence proceeding in a NW direction [N 43-35-37 W] along a line for an estimated distance of 655.1 ft. to a point,

Thence proceeding in a NE [N 48-3-54 E] direction along a line for an estimated distance of 1,237.6 ft. to a point, [X: 928625.216316 & Y: 729572.746135], said point being, THE POINT OF BEGINNING.

SECTION 2: That the requirements of Section 3.2 of the Zoning Ordinance adopted on the 18<sup>th</sup> day of July 2019, and the law in such cases made and provided has been satisfied. An opportunity for a public hearing was afforded anyone having an interest or property right which may have been affected by this zoning amendment, said notice being published in the Savannah

Morning News, on the 11<sup>th</sup> day of July 2025, a copy of said notice being attached hereto and made a part hereof.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

EFFECTIVE DATE: This ordinance shall be effective as of the date hereof.
